Jasper County, Iowa (the "County") Conservation Board met Monday, September 18th to conclude evaluations of the CMaR proposals and interviews. The Director and 3 Conservation Board Members were present at the interviews and evaluation meeting.

Each RFQ & RFP submission was scored following group discussion and the firms with the top 5 highest composite scores were invited to interview. The basis of scoring was outlined in the RFP and submissions were evaluated on 4 categories: Qualifications, Pre-Construction & Sustainability (RFP) Approach, CMaR Fee (Cost) Approach and Interviews. Each category was scored from 1-50 for a maximum score of 200.

After evaluation of the submissions, the committee recommended the CMaR firm who offered the best value to the County based on the published criteria and scoring evaluation. The board subsequently voted to move proceed with negotiations for Pre-Construction activities in preparation for a Guaranteed Maximum Price (GMP) contract with <u>Greiner</u> <u>Construction</u>.
