NOW, THEREFORE, BE IT ENACTED BY THE BOARD OF SUPERVISORS OF JASPER COUNTY, IOWA:

Authority

The Authority for this Ordinance is Iowa Code Section 331.302, County Legislation.

Purpose

The purpose of this ordinance is the establish a signalized school crosswalk on East 124th Street South located 635 feet north of the intersection of East 124th Street South and Highway F-62 East.

Ordinance

A signalized crosswalk is hereby established on East 124th Street South, located 635 feet north of the intersection of East 124th Street South and Highway F-62 East, in Jasper County, Iowa.

Enforcement

Iowa Code Sections 321.257, and 321.325 through 321.330 are hereby adopted and incorporated by reference as if fully set forth herein. Violations of this Ordinance for signalized crosswalk shall be enforced as violations of the referenced sections of the Iowa Code.

Effective Date

This Ordinance shall be in full force and effect from and after its passage, adoption and publication, as provided by Iowa law.




