ORDINANCE ESTABLISHING THE SERVICE AREA SYSTEM "B" ROAD CLASSIFICATION IN JASPER COUNTY, IOWA

The purpose of this Amendment No.4 to Ordinance No. IV-1 is to add to the "B" System those roads that have been evaluated and serviced as Level "B" roads for many years and to remove those treated as Level A Service roads. The purpose of this amendment remains the same as stated in the original ordinance and this action is in compliance with Section 309.57 of the Code of Iowa.
