ORDINANCE NO. IV-3

ORDINANCE TO ESTABLISH RURAL ROAD STREET AND AVENUE DESIGNATIONS

The purpose of this ordinance is to establish, within Jasper County, a street and avenue identification system to enable the assignment of rural residence and business addresses, in order to better enable location of said residences and businesses by emergency vehicles, delivery services, and the general citizenry of Jasper County and the State of Iowa.

SECTION NO. 1: GENERAL DESIGNATION LAYOUT

In general, secondary roads running in an east-west direction will be designated as AVENUES, while those running in a north-south direction will be classed as STREETS. Avenues and streets running in a true east-west or north-south direction will be designated by numbers, while those following diagonal, meandering, or irregular routes will be named. The beginning base reference point for all numbered streets and avenues will be the southeast corner of the Jasper County Courthouse Square in Newton, Iowa. All named streets and avenues within any given congressional township shall begin with the same letter of the alphabet, as a further aid to location. Streets and avenues within unincorporated communities shall use, insofar as possible, those names and/or numbers shown on the original plats of those communities. This rural street and avenue designation ordinance does not apply within the corporate boundary of any incorporated community within Jasper County, where their identification system shall take preference.

Should it be necessary to assign a name to the new highway, the Jasper County Engineer shall recommend the name to the Jasper County Board of Supervisors, who shall have the final decision concerning the name assigned.

SECTION NO. 4: DEPOSITORY FOR ESTABLISHED ROAD DESIGNATION RECORDS

The Office of the Jasper County Engineer shall be the designated

location of the official records of the assigned numbers and/or

names for the rural road system of Jasper County.

SECTION NO. 5: TREATMENT OF ROADS ON JASPER COUNTY BORDERS

Both Jasper County and adjoining counties may designate different
numbers or names on the county line highways, in keeping with the
system adopted by each county. In those instances of dual designations,
the number or name assigned by Jasper County shall apply only to
those residents residing on the Jasper County side of the county
line road.



SECTION NO. 6: SEVERABILITY

If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.

SECTION 7: EFFECTIVE DATE OF ORDINANCE

This ordinance shall be in effect after it's final passage, approval and publication as provided by law, and as the necessary and applicable signs are erected.


