Tuesday, February 11, 2014 the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Brock, Stevenson and Carpenter present and accounted for; Chairman Brock presiding.

Representatives from Prairie City and the Jasper County Economic Development Corporation held a consultation with the Supervisors in regards to a voluntary annexation into Prairie City of part of Government Lot 4 in Section 2, Township 78 North, Range 21 West of the 5th P.M., Parcel E in the East Half of the Southeast Quarter of Section 35, Township 70 North, Range 21 West of the 5th P.M. AND the East 6 acres of the South Quarter of the Northeast Quarter Southeast Quarter of Section 36, Township 79 North, Range 21 West of the 5th P.M. all in Jasper County, Iowa. The Supervisors will have on their February 18, 2014 agenda a resolution for consideration of the voluntary annexation application.

County Engineer, Russ Stutt, presented to the Board a resolution awarding a contract for PCC unbounded overlay on Route T38 North of Lynnville and bids for the purchase of two pickups for the Secondary Roads Department.
