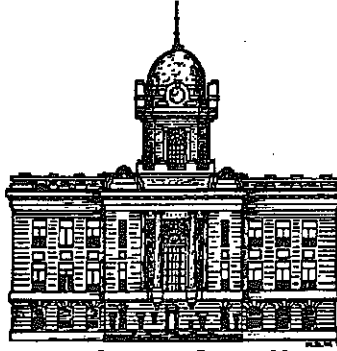

**Reception for Elected Officials
immediately following the meeting**

Tuesday, December 23, 2014 the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Brock, Stevenson and Carpenter present and accounted for; Chairman Brock presiding.

Community Services Director Jody Eaton updated the Board on the Central Iowa Community Services activities. Eaton said that she had been appointed the organization's Operations Director. She stated that the County staff would be evaluated and assigned duties. Eaton said that psychiatric services would be added at the local offices.

Motion by Stevenson, seconded by Carpenter to authorize the HIPAA Privacy Officer and Security Officer to sign business associate agreements.
