Tuesday, October 6, 2015, the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Carpenter, Brock & Stevenson present and accounted for; Chairman Carpenter presiding.

The Board opened sealed bids for the 278.3 acres of cropland to be rented for the 2016 – 2018 term.

The opening bids were as follows: (Per Acre) Todd Terpstra \$198, Dean VanKooten \$261, Eric Siebrecht \$150. The current tenant, Mindy Campfield, bid \$265. The Supervisors opened the process to further bidding and the final bid was made by Dean VanKooten in the amount of \$273 per acre.

Motion by Brock, seconded by Stevenson to accept the bid made by Dean VanKooten to farm the County Farm for the term beginning March 1, 2016 and ending February 28, 2018 in the amount \$273 per acre on 278.3 acres, (\$75,975.90) each year for two years.
