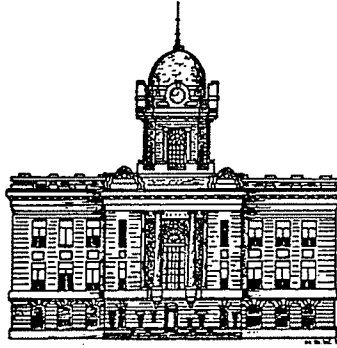

PUBLIC INPUT & COMMENTS

March 14, 2017

Tuesday, March 14, 2017 the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Brock, Carpenter and Cupples present and accounted for; Chairman Brock presiding.

Human Resources Director, Dennis Simon, presented to the Board a resolution to hire a part-time female jailer for the sheriff's Office and a site manager for the Elderly Nutrition Department.

It was determined by the Board that because of the larger bagger capacity, bigger gas tank, and larger size of engine it would be more cost effective in the long run to purchase the John Deere Z915E and save on man hours.
