Tuesday, May 2, 2017 the Jasper County Board of Supervisors met in regular session at 9:30 a.m. with Supervisors Brock, Carpenter and Cupples present and accounted for; Chairman Brock presiding.

CICS Director, Jody Eaton, spoke to the Supervisors about the importance of mental health services and asked that they approve a proclamation to recognize the month of May as Mental Health Month.

Motion by Brock, seconded by Carpenter to approve a proclamation proclaiming May, 2017 as Mental Health Month.

Director Eaton introduced Julie Gibson from the House of Mercy, who will help develop access to mental health services in Jasper County. Eaton also updated the Board on CICS activities for the first quarter in 2017, stating that there was a 194% increase in crisis line calls in the first quarter of the year.

Conservation Director, Keri Van Zante, told the Board that the Mariposa Lake Restoration Project is estimated to cost \$2,334,329. The Iowa DNR is slated to pay 82% or \$1,918,885 of the total cost of the project leaving 18% or \$415,444 which would be the County's share of the cost of the project. Van Zante stated that she had raised \$277,716 in grants and \$17,728 in other monies leaving \$120,000 for the County to provide for its portion of the project. The lake will be bigger, deeper and the whole campground will be improved.

Motion by Carpenter, seconded by Cupples to approve a 28E Agreement providing for the use of Outside Law Enforcement Agencies, which include Newton, Baxter, Colfax, Monroe, Prairie City, Marshalltown and Jasper County, for joint enforcement services to the Iowa Speedway during events, concerts, races and rallies held at the Iowa Speedway.

County Engineer, Russ Stutt, presented to the Board quotes for the purpose of purchasing rock salt and they are as follows:

The Engineer stated that the average amount of salt purchased each year is about 1500 tons.
