## **DISCUSSION ITEMS:**

Reports were presented by Cantu and Read.

**Park entry sign/Wilcox Memorial**. Staff is working on developing a new entry sign template for our major parks and a small matching sign for minor parks. The first to be done will be Ashton Wildwood Park, as a memorial to Denis Wilcox. Staff will be working with Mingo Products for the base of the sign and Krampe Welding for the conservation logo on the sign.

**Farm Contracts.** Board members would like for Van Zante to contact county attorney about cancelling farm contracts to rebid in the fall.

**Yurt Project.** Van Zante presented bids from Pacific Yurts for two 24' yurts at Ashton Park. Each basic yurt will be \$15,680, but then will go up in price when additional pieces are added. Board members asked for clarification about the fabric windows included with the yurt. Van Zante will contact Pacific Yurts to get information about what fabric windows are made of and if they can open. Van Zante will be writing the Prairie Meadows grant for these yurts.

**Grants and Earmark Funding.** Van Zante will be applying for Earmark funding for the Red Rock Prairie Trail bike extension to Mitchellville and the Nature Center Project.

**Grants.** Cantu is working on a Build with Bags grant for new benches at Mariposa and a Jasper Community Foundation grant for paddleboards. Oldsen is applying for a Trees For Kids grant for tree planting at Krumm. A Prairie Meadows grant will be written by Van Zante for the yurt project at Ashton as soon as the grant cycle opens.

Camping and Cabin Planning Review. Nothing identified.

**Nature Center.** Nothing identified.

**Other.** Memorial for Jerry Ratliff's parents has raised \$1600. Oldsen and Van Zante are meeting with SWCD to request funding for floating wetland project. Marshall County Conservation has invited board members and staff to visit in July to observe their milling operation.

**Board Member Concerns.** E-bike policy will be discussed at next meeting.
