DISCUSSION ITEMS:

A naturalist report was presented by Read.

A RESOLUTION AUTHORIZING JASPER COUNTY'S SUBMITTAL OF AN APPLICATION FOR FUNDING FROM THE STATE RECREATIONAL TRAILS PROGRAM TO THE DEPARTMENT OF TRANSPORTATION (DOT) FOR THE FUNDING OF DEVELOPMENT OF THE RED ROCK PRAIRIE TRAIL- ACTION 21-40.

Whereas, the Jasper County Conservation Board is a valid and functioning entity of Jasper County; and

Whereas, the State Recreational Trails Program provides funding at the state level to local jurisdictions for the development of eligible projects; and

Whereas, the program is administered by the Iowa Department of Transportation which prioritizes and ranks all project applications; and

NOW, THEREFORE, BE IT RESOLVED BY THE JASPER COUNTY CONSERVATION BOARD THAT:

- 1. Jasper County Conservation Board supports and approves the application made for State Recreational Trails Funds
- 2. Jasper County Conservation Board hereby commits to the Iowa Department of Transportation to secure matching monies as required by the State Recreational Trails Program funding.
- 3. Jasper County Conservation hereby commits to accepting and maintaining these improvements for a minimum of twenty (20) years following the completion.
- 4. The Jasper County Conservation Director is hereby authorized to approve and execute the application and award agreement on behalf of Jasper County Conservation Board.

Motion by Stone, second by Friedman to approve the resolution authorizing Jasper County's submittal of an application for funding for the State Recreational Trails Program for the funding of the development of the Red Rock Prairie Trail. Motion carried unanimously.

Wilcox Green. The Wilcox children have decided on the name of "Wilcox Green" for the open area at Ashton Park. Kramer asked that we be sure the entrance sign into Ashton also commemorate Wilcox as well.

UHLENHOPP BUILDING BIDS- ACTION 21-41. Van Zante presented bids for the replacement of the building lost during the derecho at Uhlenhopp. Schwartz Construction bid \$61,700, Denny Clayton Building Sales bid \$84,865, and Pro-Line Building Company bid \$72,587. Motion by Herbold,

second by Smith to accept Schwartz Construction's low bid of \$61,700 and move forward with the project. Motion carried unanimously.

Uhlenhopp Arboretum and Sugar Creek Grand Opening. A grant opening will be held on Friday, August 6 at 5:00 pm.

Hayground at Nature Center Area. An individual has contacted Van Zante with interest in haying the nature center area hayground for the rest of this year. Board members said to move forward with advice from the county attorney.

Grants. IDALS grant for the floating wetland project, CARES ACT and SRT grants for the Red Rock Prairie Trail project, and Prairie Meadows Grant for the yurt projects have all been submitted.

Camping and Cabin Planning Review. Nothing identified.

Nature Center. Kramer and Van Zante will have a naming rights conversation with the King Family to see how we are progressing.

Other. Van Zante updated board members about the Miller-Meeks visit. Friedman would like staff to investigate having something like the "School of the Wild" as they do in Iowa City schools.

Board Member Concerns. Stone asked that kiosks in the park either need to be updated or removed. He also asked to remove the crumbling wood benches at Krumm.

ADJOURNMENT- ACTION 21-42. With no further business appearing, motion by Herbold second by Smith that the meeting adjourn. Motion carried unanimously.
