## **DISCUSSION ITEMS:**

Staff reports were presented by Oldsen, Vander Pol and Cooling.

**Uhlenhopp Fireplace.** Vander Pol presented options for the wood burning fireplace at the Uhlenhopp Cabin- gas insert (\$5,000), electric insert (\$1200-\$1500), or leave it as is and semi-permanently close the door on the fireplace so that renters cannot start a fire in it. Board members decided to leave the fireplace as is for now and semi-permanently close the doors with screws.

**Uhlenhopp Restroom Update.** Van Zante ordered a restroom from CXT to match all of the others in our parks. The delivery time is 90-120 days and the total cost with delivery is \$20,548.

**OFFICE MANAGER POSITION- ACTION 22-12.** Van Zante prepared and sent a request to the Board of Supervisors to make Jade Read full time. Motion by Freidman, second by Stone to make an official Conservation Board recommendation to convert the office manager position from part time to full time pending supervisor budget approval. Motion caried unanimously.

**Farm Lease Bids**. Bid openings will be held at the November meeting for a 3-year contract each for the Nature Center Hayground and for the Lillian Johnston Farmground.

**Wilcox Dedication.** The Wilcox Dedication will be held at Ashton Park on Tuesday, November 2 at 1:00 pm. Van Zante will invite the newspaper as well as all staff and donors.

**Grants.** LAWCON grant for Mariposa Campground is moving forward, Oldsen received a Trees for Kids grant for a tree planting at Krumm Preserve, Trees forever grant has been expanded to do a tree planting at both Ira and Mingo Parks. The Prairie Meadows grant for the yurts at Ashton Park was not successful.

**Camping and Cabin Planning Review.** Mariposa campground will begin moving forward. Uhlenhopp cabin rental is starting to be booked most weekends.

**Nature Center.** A donation for \$25,000 was received for the Nature Center Project.

**Other.** Van Zante passed around a photo of a mockup for the new entry sign at Mariposa in honor of Dennis Black. Kramer is working with Blacks daughter on donations for that project. A falconry request was received asking for an individual to be able to hunt her falcon at county areas. More information was requested. Van Zante will follow up with questions are report back to board members. Elliott Uhlenhopp's former church members requested permission to donate trees to Uhlenhopp Arboretum. A fruit orchard was suggested by board members for their possible donation.

Board Member Concerns. Nothing reported.
