Also, in attendance were VSO/Secretary Keith Thorpe and Jasper County Human Resource Director Dennis Simon.

<u>Approve Minutes 10 November 2021 Regular Meeting:</u> Marta Ford made a motion and Mike Naber seconded to approve the minutes as presented. The motion passed unanimously.

Unfinished Business:

- 1. <u>Veterans Outreach Tasks:</u> The commission's workshop will be held later.
- 2. <u>Veterans Outreach:</u> Alyssa and Keith attended the 12 November 2021 Park Center Veterans Appreciation Day Event. Approximately 25 veterans and spouses attended. The program lasted about 30 minutes. Poems were read, music from the five service branches played and a list of Park Center veterans was read. Alyssa and Keith shared with the group that we were only two block away and that we are here to serve them and would be more than willing to visit with them at their residents. It was a great experience!
- 3. <u>County Jail & Veterans:</u> Susan shared with the commission the following: When a veteran is jailed, they are provided with literature concerning their confinement and their rights. Also, when they are released, they are always provided a phone. Keith shared the following: Our office receives the names of jailed veterans from the Chief Jailer Wendy Hecox. Ms. Hecox also notifies Sara Glenn with <u>Veterans Justice Outreach</u> the names of the jailed veterans. The goal of VJO is to avoid unnecessary criminalization of mental illness and extended incarceration among veterans.
