## **DISCUSSION ITEMS:**

Staff reports were presented by Ratliff, Oldsen, VanderPol, and Read.

**MOWER REPLACEMENT BIDS- ACTION 22-31.** Ratliff presented bids from Prairie Ag for a Cheetah 2 Scag Mower. We will be trading in 3 mowers. With trade in and an upgraded seat, the mower will cost \$6,000. Motion by Kramer, second by Stone to accept the bid from Prairie Ag for a Cheetah 2 Scag Mower for \$6,000. Motion carried unanimously.

**Johnston Farm Management Plan.** Board members discussed the current farm plan for the Lillian Johnston Farm, which includes farming the nonerodible ridge top ground with cover crops after harvest, and all of the rest of the ground is seeded down to prairie and shrubs. The intention of the area plan is to intermingle agriculture and wildlife habitat in a cohesive manner. All board members agreed that this is how they want the property to remain to be managed.

**Cross Country Ski Trail Grooming Plan.** After much public input, VanderPol asked if board members would want to consider purchasing a different snowmobile to create groomed trails for cross country skiing at Uhlenhopp and Krumm. Board members were concerned that snowmobile tracks would encourage other snowmobiles in our parks and therefor vetoed the idea.

**Naming Rights for a Conservation Area.** Van Zante was approached by a park user about how much money it might take to rename a park (Sugar Creek Wildlife Area). Board members said that if the park hadn't been donated with the name attached to it, they might consider the idea. Instead, they asked if the person might be interested in donating and having a cabin named for them at Sugar Creek. Van Zante will follow up.

**Grants.** Van Zante is applying for the FLAP, TAP, and Wellmark Foundation grants for the Red Rock Prairie, as well as a Prairie Meadows grant for Yurts at Ashton Park. Cantu is applying for a build with Bags grant for new benches at Mariposa.

Camping and Cabin Planning Review. Nothing identified.

**Nature Center.** A Caring for Conservation auction of being planned for April 2, 2022 from 6-9:00 pm at The Thunderdome.

**Other.** Nothing identified.

Board Member Concerns. None identified.
