# For Emergency Assistance:

# **Eligibility**

To be eligible for Emergency Financial Assistance the applicant must have a minimum aggregate of 90 days federal duty, other than training, basic training and to have been discharged under other than dishonorable conditions. Necessity will be determined by the veteran's current financial situation, using only what income and expenses can be verified for the 30 days prior to the request for relief. The submission of incorrect or false information may at any time limit or terminate the relief provided by this program. Any veteran, regardless of their current financial situation, can apply for any relief they deem an Emergency.

Note: We had a **20-years served, honorable discharged Iowa National Guard person** request financial assistance. She had **NO** Federal Training in her twenty years. With our "eligibility" statement, she would not be eligible for assistance. She did not have **90 Days Federal Duty.** 

lowa Code 35.1 considers her a veteran. It would be difficult to say no to this lowa Veteran.
