Dear Supervisors,

A request for bids for ten (10) motor-graders was sent out to two (2) potential bidders on January 26th, 2022. The potential bidders were Ziegler (CAT) and Murphy Tractor (Deere). Base, alternate, and voluntary alternate bids were requested. Each option was based upon a machine service life of seven (7) years and 10,000 engine hours and the inclusion of a full machine warranty over the entire service life. On February 9th, 2022 we received base and alternate bids from both Ziegler and Murphy Tractor. The bids received were as follows:

After review of these bids, our department decided the base bid option was incapable of providing the hydraulic or engine power necessary to carry out winter operations in the most effective and efficient manner. The current fleet of CAT 12M3's, equivalent to the CAT 140 above, are not capable of getting a motor-grader back onto the roadway from a ditch in one move using the moldboard plow. Nor are they capable of punching through heavy wet or deep snow at top gear or speed. Given this consensus, the base bid was eliminated from further evaluation.

The analysis carried out by my department compared the hourly cost of ownership between the Deere 770G and CAT 150. The hourly cost of ownership is influenced by the upfront machine costs and the residual value of the machine at the end of its service life. Each bidder was asked to indicate whether this residual value would be paid out through a guaranteed repurchase or guaranteed trade-in. The following shows the method of residual cost payout and the cost of owning each unit per hour:

Although the CAT 150 is the better value from a cost of ownership perspective, its upfront cost would require additional FY23 budget funds. This prompted my department to look at a third option for capturing more residual value from the Deere 770G units. That option would be, at the end of service life gain board approval to allow secondary roads, to directly auction off the units. Readily available information suggests that a residual value of \$100,000 per Deere 770G unit would be possible. If this idea were acceptable to the board, the cost of owning the Deere 770G drops to \$22.20 per unit per hour. Moreover, the Deere 770G upfront cost is within the limits of the FY23 equipment budget line item. Lastly, the Deere 770Gs are being provided with the upgraded, enclosed, circle at no additional costs. This in our opinion, if auctioning the units at end of service life is a possibility, makes the Deere 770G a better overall value.

After much consideration, and with the conditions noted above, the Jasper County Highway Department recommends approving the alt bid submitted by Murphy Tractor for ten (10) Deere 770G motor-graders at a total cost of \$3,220,000. Delivery date, according to Murphy Tractor, if ordered by February 23, 2022, could be as early as October 2022. Although we would work with them to have the machines delivered closer to March 2023.
