DISCUSSION ITEMS:

Staff reports were presented by Ratliff, Cooling, VanderPol, and Read.

WAGAMAN MILL MANAGEMENT PLAN- ACTION 22-34. Herbold, Ratliff, Vander Pol and Dunsbergen met at Wagaman Mill to discuss required maintenance to keep the mill in operation. Sand and debris have to be removed from to inside pit every few weeks and trees have to be removed from the dam after nearly every high-water event. Both actions are very dangerous

for staff to accomplish. Board members would like to meet with Lynnville Historical Society members to discuss these safety concerns, along with concerns regarding how the building will be maintained in its deteriorating conditions. The existing lease agreement identifying JCCB as managing the wheelhouse expired in May 2023. Van Zante will meet with county attorney to discuss this lease. Motion by Herbold, second by Kramer that staff cease the maintenance in the pit of the mill and on the dam outside the mill due to safety concerns. Motion carried unanimously.

NATURE CENTER REDESIGN CONTRACT- ACTION 22-35. Board members felt they now have a thorough understanding of the nature center re-design contract from Studio Melee. Motion by Stone, second by Herbold to approve the nature center re-design contract form Studio Melee. Motion carried unanimously.

CVT Bike Trail Damage Plan. Herbold visiting the damaged section of the bike trail with an engineer and contractor. From that meeting, he suggested we choose a section of damaged trail to excavated and investigate what is happening underground. Herbold will work with staff to do this later this spring.

CITY OF MINGO BIKE TRAIL SIGN REQUEST- ACTION 22-36. Gary Bartles, the Mayor of Mingo, contacted Van Zante about placing school district signs along the Chichaqua Valley Trail. Board members were supportive of the idea, as we partner with school districts for several projects already. Ratliff will attend the council meeting to discuss specifics regarding sign size and distance off the trail. Motion by Herbold, second by Stone to allow two Colfax Mingo school district signs on the Chichaqua Valley Trail. Motion carried unanimously.

Lillian Johnston Wildlife Area Bioreactor. Herbold suggested looking at the potential for a bioreactor on the Lillian Johnston Property to help with ground water management and denitrification. Herbold and Van Zante will visit the site together in the next few weeks. Motion by Kramer, second by Stone to begin the process of installing a bioreactor on the Lillian Johnston Wildlife Area. Motion carried unanimously.

Cabin Cleaning. Board members suggested getting some costs for someone other than staff to clean the cabin at Uhlenhopp. Van Zante will get some bids and bring back to the board next month.

ATV ACCESSIBILITY/MOBILITY PROJECT- ACTION 22-37. Van Zante presented a project that volunteer Bill Yeager has initiated. He would like to see and ATV available to give tour of our parks to people with mobility issues. Van Zante as spoken to the county attorney about volunteers leading these tours and have now worked through the process. Fundraising is underway

and \$6,000 has been committed so for to purchase a 4-door machine with a cab that could be used for this and for work purposes. The ATV at Uhlenhopp is not reliable any longer, so this machine could serve a dual benefit. Cost estimates have ranges between \$17,000 and \$25,000. Motion by Herbold, second by stone to commit up to \$5,000 for this project. Motion carried unanimously.

Grants. Van Zante applied for the FLAP, TAP, and Wellmark Foundation grants for the Red Rock Prairie, as well as a Prairie Meadows grant for Yurts at Ashton Park. Cantu is applying for a build with Bags grant for new benches at Mariposa.

Camping and Cabin Planning Review. Nothing identified.

Nature Center. A Caring for Conservation auction of being planned for April 2, 2022 from 6:00-9:00 pm at The Thunderdome, and a Caring for Conservation Slipstream Concert will be held at Ashton Park on June 25, 2022 at 6:00 pm.

Other. Nothing identified.

Board Member Concerns. None identified.

ADJOURNMENT- ACTION 22-38. With no further business appearing, motion by Kramer second by Stone that the meeting adjourn. Motion carried unanimously.
