Tuesday, September 20, 2022, the Jasper County Board of Supervisors met in regular session at 9:30 a.m. Supervisors Talsma, Carpenter, and Cupples present and accounted for; Chairman Talsma presiding.

Motion by Cupples and seconded by Carpenter to open a Public Hearing concerning the rezoning request of Parcel 03.05.100.006 created within Parcels 03.05.100.001 & 03.05.100.003 from Agriculture to General Industrial.
