**DISCUSSION ITEMS:**

A naturalist and staff report were presented by Cantu and VanderPol.

**Tour of Mariposa.** Van Zante and VanderPol took board members on a tour of the new campground location, the old campground, and the new nature playscape trail.

**CENTRAL IOWA WATER PROPOSAL FOR NEW WATERLINE TO MARIPOSA-ACTION 23-16.** Central Iowa Water submitted a proposal for \$150,000 to add a new 4" water main to allow for the usage the new campground/cabins will require at Mariposa. Van Zante spoke to Jim LaPlant and he was able to reduce the cost of the project by 50% of the original cost. Motion by Kramer, second by Stone to spend up to \$80,000 on the water service installation to the new campground at Mariposa. Motion carried unanimously.

**CVT Repair Proposal.** Snyder and Associates will be submitting a proposal for the repair of the CVT. Van Zante spoke in length with Auditor Dennis Parrott and he said that since Snyder and Associates is the only firm that provides the specialized service and experience needed to repair the trail, then no bids are required for the design services for the project.

**Grants.** Van Zante will submit the Destination Iowa Grant for the Nature Center Project.

**Camping and Cabin Planning Review.** November's meeting will begin the planning sessions for the new campground at Mariposa. Van Zante will have a large map printed to use for the planning process.

**Nature Center.** Nothing identified.

**Other.** Nothing identified.

**Board Member Concerns.** Nothing identified.
