## **DISCUSSION ITEMS:**

A written naturalist report was presented, and staff report was presented by Oldsen.

**CONSERVATION EQUIPMENT BID OPENING- ACTION 23-24.** Herbold opened bids for each piece of equipment. Dump Trailer: \$676.75 by Glenn Jontz, \$1254 by Ryan Dannon, \$755 by Mike Black, and \$1200 by Randy Ray. Big Red Honda 3-wheeler: \$300 by Randy Ray, and \$896 by Ryan Dannon.

Yamaha Snowmobile: \$125 by Mike Black and \$150 by Austin St. John. Western Snowplow: \$125 by Mike Black. Motion by Kramer, second by Stone to approve the high bidders for each piece of equipment: \$1250 from Ryan Dannon for the dump trailer, \$896 from Ryan Dannon for the 3-wheeler, \$150 for the Yamaha snowmobile from Austin St. John, and \$125 for the Western snowplow from Mike Black. Motion carried unanimously.

**Grants.** Van Zante submitted 2 Fish Habitat Grants and Oldsen submitted a small habitat grant for Mariposa.

**Camping and Cabin Planning.** VanderPol will be at the January meeting with beginning bids.

**Nature Center.** Kramer would like to offer a \$25,000 matching grant challenge for the nature center project.

**Other.** Board members asked about any news regarding a new board member with Smith's term ending December 31, 2022, but no decision has been made yet. Stone's land donation has been surveyed and it is 6.5 acres.
