Kevin Luetters and Jamie Elam thanked Margot Voshell for supporting them and her service to the Board of Health. Jamie has completed all annual pool, tanning, and tattoo inspections in Jasper and Poweshiek Counties. Inspections have gone well but will need to do one follow-up inspection in January. All follow-up inspections with local pumper trucks will be completed in January and will need to be in complete compliance with the inspection. All 2022 CEUs have been submitted to the State. Septic inspections have slowed due to weather, but there are a few still installing on nice days. Daily work continues and they already looking into a very busy 2023 work schedule. The DNR grant has gone very well for new septic systems. Around \$400,000 worth of systems have been installed and there are 4 or 5 remaining to complete.

2.) Mid Iowa Community Action (MICA) – WIC, First Five, I-smile:

December 2022 newsletter. See 2-page attachment

Via Zoom, Sierra Stevens stated there has been an increase of 21 WIC families between the Colfax and Newton clinics. They are using a new breastfeeding program to encourage breastfeeding. 71% of Colfax clients and 64% of Newton clients are breastfeeding. The percentage dropped off after 6 months to 33% in Colfax and 36% in Newton. MICA has 2 lactation consultants, and the dietitian is going through training as well. MICA received the state grant to provide 1st Five services to Jasper County. MICA is currently looking for a Child Care Nurse Consultant to serve Jasper County. Families served at WIC clinics are 370 in Newton and 61 in Colfax. I-Smile is identifying the needs in the Jasper County schools and has started scheduling Floride treatments for Newton Schools.

3.) EFR report: via Zoom, Kariee Bishop – EFR is working with the schools, Lynnville-Sully and Newton, to present the Too Good for Drugs program and an 8th-grade at-risk support group. Kariee also reported Your Life Iowa has had over 1,000 impressions through social media, posters, calls, and texts.

Item 8: Budget FY23 update and FY24: Budget date from 7/1/2023-6/30/2024, See I page attachment Becky Pryor, Administrator, will present to Board of Supervisors during budget hearings later this month. The Board of Health is welcome to attend.

FY23- Changes include an increase mileage from \$1000 back to \$2000 (current rate is 65.5 cents per mile), decrease phone to \$2000 and a decrease pass thru grants to \$65,000.

FY24- The budget was figured with the number from the Auditor office for raises. They said to take half the compensation board's recommendation of 12%, which is 6% for non-union but may be less depending on what the Board of Supervisors decides. Union has a negotiated contract and Melissa is the only Union employee. The Board of Supervisors has not approved raises yet, but it is recommended to stay consistent with the across-the-board pay plan raise as approved by the Board of Supervisors. As of right now, we will not have COVID grants for FY24. PHEP grants fluctuate based on needs and grants.

- Jasper County Health Department report:
 - O Home Care: Currently have 8 clients, one started waiver services last month. There have been issues finding home care agencies for homemaker services only, most agencies require nursing and home care aide services to provide homemaking. The few we are working with are understaffed and have no one to see out of town clients. FY24 cost projection stands at \$42,000. Cost may vary due to the number of clients and hours per month.
 - O SafeKids: At the Jasper County Cares meeting on 01/11/2023 we presented our CPPC plan for this spring and summer and were granted approval. We plan to hold our SafeKids pool party again for all 2nd graders participating in the YMCA Safe Swim classes. We will educate the students and their families about sun and summer safety. We will give out safety bags with sun and summer safety items. We plan to also purchase car seats for the Pregnancy Center as well as Safekids to be installed by a CPS tech. They are available to those in need by appointment or at a car seat check event.
 - PPE Stockpile: We still have been giving away masks, gloves and gowns to the LTC facilities and other community partners. We still have plenty of gowns and N95 masks. We do still have some gloves and surgical masks as well.
- Jasper County Cares updates- meetings, resource guide, and projects: See 52-page attachment Becky reported the resource guide is continuing to be updated. It is posted on the website, and we will continue to update it as changes are needed. Becky stated the providers are looking for ways to help the schools with suicide prevention. They had a good breakout session including Maternal and Child Health service providers.

MEMORANDUM OF UNDERSTANDING (MOU) State Advisory Board

Between

University of Iowa Prevention Research Center for Rural Health (PRC-RH)

And

Jasper County Health Department

This Memorandum of Understanding (MOU), while not a legally binding document, does indicate a voluntary agreement to guide and advise in order to maximize the potential to achieve the aims of the center and core research project. The project is funded by the Center for Disease Control and Prevention. The project is expected to be completed over the course of approximately five years in September 2024.

I. MISSION

The mission of the PRC-RH is to improve is to address disparities in and across Midwestern communities to promote wellbeing. The long-term goal of the core research project is to test strategies for increasing the capacity of micropolitan communities in Iowa to successfully identify, adapt, implement, and evaluate evidence-based interventions in order to increase the health of Iowans.

These goals will be sought through achieving these center specific aims:

- 1) Engage with stakeholders in Iowa, surrounding Region G states and nationally, to ensure communication of the Center and PRC network research findings and products, in order to increase recognition and understanding of applied public health research and the PRCs contribution to this research
- 2) Train and provide technical assistance to public health and medical care practitioners and multisector partners to ensure a stronger public health and health-related workforce in rural Iowa and other Region G states.

These goals will be sought through achieving these core research project specific aims: Aim1.1: Identify barriers and facilitators to implementing EBIs; focusing on the knowledge, experience, readiness, and capacity of Local Public Health (LPH) and Community Based Organizations (CBOs) in micropolitan communities.

Aim1.2: Test the effectiveness of two implementation strategies (training and a learning collaborative) to increase readiness of LPH and CBOs to successfully implement EBIs Aim 2: Develop, test, and adapt all materials (Manual of Implementation and trainings) needed to implement Active Iowa and provide all materials via the web.

Together, the parties enter into this Memorandum of Understanding to mutually promote the health and well-being of rural Iowans. Accordingly, the University of Iowa PRC-RH and the Jasper County Health Department will operate under this MOU as follows:

II. RESPONSIBILITIES

The research team will:

• Coordinate meetings for the State Advisory Board (SAB)

- Provide a 'Research and Translation Agenda' for center and core research activities for review and input by SAB members
- Conduct center level training activities
- Communicate and disseminate center level activities
- Provide a yearly stipend of \$500 to the organization of each member of the SAB

The partnering organization will:

- Participate in the SAB meetings
 - O Year 4-5: Meetings will be three times year and for one hour
- Provide input and feedback on the research and translation agenda
- Provide input and feedback, and assist with the identification of center level training needs
- Assist with communication and dissemination of center level activities
- Provide input and feedback on the design of the research
- Support the research team in identifying and connecting with local stakeholders
- Provide input and feedback to the analyzed and presented data and assist in interpretation
- Help disseminate research study findings and report to the key stakeholders in the community

III. TERMS OF UNDERSTANDING

The term of this MOU is for a period of approximately five years from the effective date of this agreement. It shall be reviewed yearly to ensure that it is fulfilling its purpose and to make any necessary revisions.

Either organization may terminate this MOU upon thirty days written notice without penalties or liabilities.

Authorization

The signing of this MOU is not a formal undertaking. It implies that the signatories will strive to reach, to the best of their ability, the objectives stated in the MOU.

Using Standing Orders for Administering Vaccines: What You Should Know

The use of standing orders for vaccination facilitates the delivery of immunization services to patients in clinics, hospitals, and community settings.

Standing orders have been shown to increase vaccination coverage rates.

FOOTNOTE

1 The Task Force was established in 1996 by the U.S. Department of Health and Human Services to identify population health interventions that are scientifically proven to save lives, increase lifespans, and improve quality of life. The Task Force produces recommendations (and identifies evidence gaps) to help inform the decision making of federal, state, and local health departments, other government agencies, communities, healthcare providers, employers, schools, and research organizations. What are standing orders?

Standing orders authorize nurses, pharmacists, and other appropriately trained healthcare personnel, where allowed by state law, to assess a patient's immunization status and administer vaccinations according to a protocol approved by a medical director in a healthcare setting, a physician, or another authorized practitioner. Standing orders work by enabling assessment and vaccination of the patient without the need for clinician examination or direct order from the attending provider at the time of the interaction. Standing orders can be established for the administration of one or more specific vaccines to a broad or narrow set of patients in healthcare settings such as clinics, hospitals, pharmacies, and long-term care facilities.

Who recommends standing orders for vaccination?

The Community Preventive Services Task Force (Task Force): The Task Force¹ recommends standing orders for vaccinations based on strong evidence of effectiveness in improving vaccination rates:

- 1. in adults and children,
- 2. when used alone or when combined with additional interventions, and
- 3. across a range of settings and populations.

The Centers for Disease Control and Prevention (CDC): CDC's Advisory Committee on Immunization Practices (ACIP) specifically recommends standing orders for influenza and pneumococcal vaccinations and several other vaccines (e.g., hepatitis B, varicella). What are the elements of a standing order?

A comprehensive standing order should include the following elements:

- 1. Who is targeted to receive the vaccine;
- How to determine if a patient needs or should receive a particular vaccination (e.g., indications, contraindications, and precautions);
- Procedures for administering the vaccine (e.g., vaccine name, schedule for vaccination, appropriate needle size, vaccine dosage, route of administration);

- **4.** Provision of any federally required information (e.g., Vaccine Information Statement);
- 5. How to document vaccination in the patient record;
- A protocol for the management of any medical emergency related to the administration of the vaccine; and
- How to report possible adverse events occurring after vaccination.

Who is authorized to administer vaccines under standing orders?

Each of the 50 states separately regulates physicians, nurses, pharmacists, and other health-related practitioners. For further information about who can carry out standing orders in your state, contact your state immunization program or the appropriate state body (e.g., state board of medical/nursing/pharmacy practice).

Who is authorized to sign the standing orders?

In general, standing orders are approved by a medical director in a healthcare setting, a physician, or another authorized practitioner. State law or regulatory agency might authorize other healthcare professionals to sign standing orders.

What should be done with the standing orders after they have been signed?

Signed standing orders should be kept with all other signed medical procedures and protocols that are operational in one's clinic setting. A copy should also be readily available for clinic staff who operate under those standing orders.

Do standing orders need to be renewed (e.g., yearly)?

Generally, standing orders will include an implementation date as well as an expiration date. Periodic review of standing orders is important, because vaccine recommendations may change over time.

Where can I find sample standing orders?

Immunize.org has developed templates of standing orders for vaccines that are routinely recommended to children and adults. They are updated as needed and reviewed for technical accuracy by immunization experts. The most current versions can be accessed by going to www.immunize.org/standing-orders.

State Ending COVID-19 Mandatory Reporting

(Des Moines, IA) Effective April I, the Iowa Department of Health and Human Services (Iowa HHS) will no longer require positive COVID-19 tests to be reported to the state Public Health Division. Since March 2020, any COVID-19 test processed in a clinical lab was required to be reported to the state Public Health Division and then to the Centers for Disease Control and Prevention (CDC). This type of reporting no longer accurately reflects the prevalence of the virus in the state.

Since the development and widespread availability of rapid in-home tests – which are not required to be reported – the case and positive test counts in the state are no longer as meaningful as they once were. Iowa currently has no mandatory reporting order for any of the other respiratory viral illnesses such as influenza, RSV, and rhinovirus.

Beginning April 1, Iowa's COVID-19 reporting dashboard will be replaced by the incorporation of surveillance data into the weekly respiratory virus surveillance report published by the Division of Public Health and available at https://hhs.iowa.gov/influenza/reports. The report will be published weekly, similar to existing reporting standards for other respiratory viruses. The Public Health Division will continue to review and analyze COVID-19 and other health data from several sources, including Syndromic Surveillance which the state has launched through the Health Information Exchange allowing near real time monitoring of illnesses.

"It's important for Iowans to know that the Public Health Division will monitor the virus, just as we do for other respiratory illnesses," said State Medical Director Dr. Robert Kruse. "The Public Health Division will continue to work collaboratively with our local health departments, healthcare partners in the state, and partners at the federal level."

Testlowa at Home will continue to offer free COVID-19 testing for lowans through the end of 2023.

Earlier this month, the U.S. Department of Health and Humans Services announced that based on current COVID-19 trends, they plan for the federal Public Health Emergency (PHE) for COVID-19 to expire at the end of the day on May 11, 2023. More information is available at
