Unfinished Business:

- 1. <u>Sully Area Outreach 2023</u>: The outreach event will be held on Saturday April 22, 2023, at the Lynnville City Hall. The rental fee for the hall is \$35.00. The event is being advertised via social media, <u>The Hometown Press</u>, <u>The Newton Daily News</u>, <u>The Advertiser</u> and <u>Radio Station KCOB</u>.
