**NATURE CENTER RFP SCORING- ACTION 24-10.** RFPs were received for the Construction Manager at Risk (CmaR) and board members read and scored the documents. RFP scores are:

94 Neumann, 91 Stahl, 79 Greiner, 74.6 Dean Snyder, 73.5 DCI,71.3 Hansen, 70.4 Lang, 67 Boyd, 63.3 Ball, 57 Jensen, 55 McGough

Adding in the RFQ scores as well, the combination scores are: 142 Neumann, 133.2 Stahl, 117.73 Greiner, 110.53 Hansen, 109.93 DCI, 108.39 Dean Snyder, 105 Boyd Jones, 103.2 Lang, 93.55 McGough, 89.15 Ball, and 88.86 Jensen

Next will be the interview phase with the top 5 scorers: Neumann, Stahl, Greiner, Hansen, and DCI.

**CVT PROJECT CHANGE ORDER NO. 1- ACTION 24-11.** Van Zante presented a change order to include the repair work needed to fix the sub-contractor mistake of tearing up the trail from Indian Creek to Hwy 117. This includes installation of 3" of HMA, assurance testing, 4-year maintenance agreement, and an additional 10 working days added to the existing contract. Motion by Friedman, second by Stone to approve Change Order No. 1 for the Chichaqua Valley Trail Repair Project. Motion carried unanimously.

MARIPOSA CAMPGROUND TRUSS AND FLOOR JOISTS BID APPROVAL-ACTION 24-12. VanderPol presented costs for trusses and floor joists for the cabin at Mariposa. Bids were received from Menards \$9930.72, RP Lumber \$9697.16, and Gilcrest Jewett \$9800.58, respectively. Gilcrest was utilized for showerhouse building products, and though just about \$100 more than RP, VanderPol suggested utilizing them so that unused items from the shower house construction can be returned and the credit can then be applied to this bill. Motion by Stone, second by Kramer to purchase the trusses and floor joists for the Mariposa Cabin from Gilcrest Jewett at a cost of \$9,800.58. Motion carried unanimously.

**North Skunk Wildlife Area.** Supervisor Cupples indicated he would like to put the North Skunk Wildlife Area up for sale since it is landlocked.

**Mariposa Housing.** Board members discussed the housing at Mariposa for the next employee. All agreed the current house would need to be removed but are not sure if a house will be added back. Members requested that HR Dennis

Simon come to the October meeting to discuss how a job description could be written to cover the question of housing. Van Zante will contact Simon.

**Grants.** None at this time.

**Nature Center.** Nothing at this time.

**Other.** The mayor of Baxter will attend the October meeting to discuss the caboose located at the CVT trailhead.

Board Member Concerns. None identified.

**ADJOURNMENT- ACTION 24-13.** With no further business appearing, motion by Stone second by Kramer that the meeting adjourn. Motion carried unanimously.
