# JASPER COUNTY, IOWA BEFORE THE BOARD OF SUPERVISORS

# ORDINANCE #61AB

AN ORDINANCE REPEALING #61A IN ITS ENTIRETY AND REPLACING IT WITH THE FOLLOWING COMPREHESIVE REGULATIONS FOR THE USE, DESIGN, INSTALLATION, MAINTENANCE AND REPLACEMENT OF ALL ON-SITE WASTEWATER TREATMENT AND DISPOSAL SYSTEMS IN ALL INCORPORATED AND UNINCORPORATED AGREES AREAS OF JASPER COUNTY AND PROVIDING FOR THE ADMINISTRATION AND ENFORCEMENT ENFORCEMENT THEREOF.

WHEREAS, Jasper County Environmental Health has acted in accordance with the Code of Iowa in promulgating the regulation set forth herein; and,

WHEREAS, the Board of Supervisors has met all statutory requirements relating to the subject matters of this Ordinance; and,

WHEREAS, the Board of Supervisors deems it necessary to, for purposes of promoting the health, safety and general welfare of Jasper County, lowa and its citizens to enact such an ordinance;

# NOW, THEREFORE, BE IT ENACTED BY THE BOARD OF SUPERVISORS OF JASPER COUNTY, IOWA:

- 1. **Title:** These regulations shall be known as the Jasper County On-Site Wastewater Treatment and Disposal System Ordinance and shall be cited as such and will be referred to herein as "this ordinance."
- 2. **Effective Date:** This ordinance shall take effect after its final passage, approval and publication as provided by law.
- Purpose: The purpose of this ordinance is to provide minimum standards to safeguard environmental, health,
  property, and public welfare by regulating and controlling the design, installation, quality of materials, location,
  operation, and maintenance or use of Jasper County's On-Site Wastewater Treatment and Disposal Systems,
  hereafter OWTS.
- 4. **Scope:** This ordinance shall regulate the design, installation, alteration, repairs, relocation, replacement, addition to use or maintenance of OWTS.

5. Applicability: The provision of this ordinance shall apply to all OWTS located in the incorporated and unincorporated areas of Jasper County.

#### 6. General:

- 6.1 Existing OWTS: Except as otherwise provided for in this chapter, a provision in this ordinance shall not require the removal, alteration, or abandonment of, nor prevent the continued utilization and maintenance of, existing compliant OWTS in existence at the time of the adoption of this ordinance.
- 6.2 **Unsafe OWTS:** An OWTS that constitutes a health or environmental hazard, or is otherwise dangerous to human life, or creates a nuisance as defined by the Code of lowa shall be declared as an unsafe OTWS.
  - 6.2.1. Authority to condemn OWTS: Wherever the Environmental Health Director, hereafter "the Director", determines that any OWTS is unsafe, the Director shall order in writing that such OWTS either be replaced or restored to a safe condition. A time limit for the compliance with such order shall be specified in the written notice. A person shall not use or maintain a defective OWTS after receiving such notice, without written approval of the Director included in the notice. The Director shall cause a report to be filed on an unsafe OWTS. The report shall state the nature of the unsafe condition.
  - 6.2.2. **Notice:** If an unsafe condition is found, the Director shall serve on the owner, a written notice that describes the condition deemed unsafe and specifies the actions required to abate the unsafe condition within a stipulated time. Such notice shall be deemed properly served if a copy thereof is: (a) delivered to the owner personally; or (b) sent by certified or registered mail addressed to the owner at the last known address with the return receipt requested. If the certified or registered letter is returned showing that the letter was not delivered, a copy thereof shall be posted in a conspicuous place in or about the structure affected by such notice. Service of such notice in the foregoing manner upon the owner's agent or upon the person responsible for the structure shall constitute service of notice upon the owner.
  - 6.2.3. All activities required to abate an unsafe OWTS shall be subject to permitting, inspection, and approval by the Director. Acceptable measures to abate an unsafe OWTS include:
    - 6.2.3.1. Connection to an approved common/public wastewater system.
    - 6.2.3.2. Approved repair of the unsafe OWTS.
    - 6.2.3.3. Approved removal and replacement of the unsafe OWTS.
    - 6.2.3.4. Extension. The Administrative Authority may grant an extension to the owner of an unsafe OWTS if said owner can show just cause why the extension is necessary and agrees in writing to all the conditions the Administrative Authority places on the extension.
    - 6.2.3.5. Failure to comply. If, after receiving notice of non-compliance from the Administrative Authority, the owner of the non-compliant OWTS fails to comply with said notice the Administrative Authority shall issue a County Infraction Citation which may include fines, abatement, and injunction prohibiting use/occupancy of any and all structures connected to the non-compliant OWTS.
- 6.3. Use of Schedule 40 PVC Required. All new OWTS shall be installed using only solid schedule 40 PVC. Any cast iron pipe that must be replaced during repair or alteration to an existing OWTS shall be replaced with solid schedule 40 PVC.

- 6.4. Location Specific Regulations. Jasper County Environmental Health may place additional restrictions on private onsite wastewater treatment for areas in which systems are allowed to discharge into surface water or when alternative wastewater solutions are available. These areas may include, but are not limited to: high-density subdivisions, watershed areas of special concern, or incorporated areas. The Administrative Authority may make a determination to individually assess all dwellings as to their compliance with these Jasper County Environmental Health regulations. Stricter standards above the minimums in the state regulations may be set by Jasper County Environmental Health.
- 6.5. No temporary occupied structures, including recreational vehicles and campers, shall be used as a primary dwelling on any parcel placed on any vacant lot or parcel unless they have an operable connection to an approved potable water system, functioning sewage disposal system and service from the electrical utility servicing that area. Jasper County Zoning Ordinance #04E will be enforced after one year. Exception: A recreational vehicle or camper may be placed on a property and used intermittently for recreational purposes or as a temporary dwelling if a building permit for a permanent dwelling on the property is in force as long as it is continuously connected to an approved potable water system and the electric utility serving that area. Proper sewage disposal is required.
- 6.6.5. Change of wastewater origin. Any action changing the origin (dwelling or building) of the wastewater shall require a permit. (Ex: Any time a new dwelling is connecting into a permitted system with the removal of the original dwelling, a permit will be required.) The OWTS must comply with lowa DNR time of transfer inspection criteria.
- 6.7.6. Additional wastewater discharge. Adding any additional discharge into an existing OWTS shall require a permit. (Ex: Discharge from an additional building, or additional discharge resulting from remodeling/addition of existing building(s). The OWTS must comply with lowa DNR time of transfer inspection criteria.
- 6.8:7. **Maintenance.** OWTS, both existing and new, and parts thereof shall be maintained in proper operating condition in accordance with the original design and in a safe, hazard-free condition. The owner shall be responsible for the maintenance of the OWTS. To determine compliance with this provision, the Jasper County Environmental Health Department Director, referred to herein as "the Director" shall have the authority to require that OWTS be reinspected.
- 6.9.8. Additions, alterations and repairs. Addition, alteration, renovations, and repairs to OWTS shall conform to that required for new OWTS without requiring that the entire existing OWTS comply with all the requirements of this ordinance. Additions, alterations and repairs shall not cause existing OWTS to become non-compliant.
- 6.10.9. **Differences.** Where, in any specific case, different sections of this ordinance specify different materials, methods of installation or other requirements, the most restrictive shall govern. Where there is a conflict between a general requirement and a specific requirement, the specific requirement shall be applicable.
- 6.14.10. Other laws. The Provisions of this ordinance shall not be deemed to nullify any provisions of local, state or federal law.
- 6.<del>12</del>.11. Validity. In the event any part or provision of this ordinance is held to be illegal or void, this shall not have the effect of making void or illegal any of the other parts or provisions thereof, which are determined to be legal; and it shall be presumed that this ordinance would have been adopted without such illegal or invalid parts or provisions.
- 6.<del>13.12.</del> **Segregation of invalid provisions.** Any invalid part of this ordinance shall be segregated from the remainder of this ordinance by the court holding such part invalid, and the remainder shall remain effective.

6.14.13. Adoption of Code of Iowa and Iowa Administrative Code. Jasper County hereby adopts by reference Code of Iowa Chapter 455B.172, and Iowa Administrative Code 567-69 as may be amended from time to time, and the same are incorporated herein by this reference the same as though frilly set forth therein.

# 7. DEFINITIONS

#### 7.1. General

- 7.1.1. **Scope.** Unless otherwise expressly stated, the following words and terms shall, for the purposes of this ordinance, have the meanings indicated in this chapter.
- 7.1.2. **Interchangeability.** Words used in the present tense include the future; words in the masculine gender include the feminine and neuter; the singular number includes the plural and the plural, the singular.
- 7.1.3. **Terms defined in other ordinances.** Where terms are not defined in this ordinance and are defined in Code of Iowa and/or The Iowa Administrative Code such terms shall have meanings ascribed to them as in those ordinances.
- 7.1.4. **Terms not defined**. Where terms are not defined through the methods authorized by this section, such terms shall have ordinarily accepted meanings such as the context implies.

#### 7.2. Definition of Terms

- 7.2.1. **Alternative Wastewater System** any type of wastewater system that does not depend on traditional or industry standard products consisting of a primary septic treatment of a septic tank with secondary treatment of the dispersal of the partially treated effluent into the soil (commonly called a subsurface lateral field).
- 7.2.2. **Licensed OWTS Installer** person licensed by Jasper County Environmental Health to install, design, and repair on-site wastewater systems in Jasper County.
- 7.2.3. **JCBOS** Jasper County Board of Supervisors
- 7.2.4. **NPDES permit** National Pollutant Discharge Elimination System General Permit #4 with the Iowa Department of Natural Resources (IDNR).
- 7.2.5. **Nuisance** As defined in the Code of Iowa. Jasper County Zoning Ordinance.
- 7.2.6. **Onsite wastewater treatment system** OWTS Systems utilized by private homes and small businesses to treat and disperse or dispose of wastewater where a municipal treatment connection is not available. The system is often referred to as a septic system.
- 7.2.7. **Owner** person(s) identified as having equitable title for the property in question.
- 7.2.8. **Site Analysis** A property and soils review and written report for the ability of the property to meet minimum requirements for regulatory compliance.

#### 8. ORGANIZATION AND ENFORCEMENT

- 8.1. **Creation of enforcement agency.** The Jasper County Environmental Health Department, herein after referred to as "the Department" and the official in charge thereof shall be known as, and herein after referred to as, "the Director". The function of the department shall be to assist the Director in the administration and enforcement of the provision of this Ordinance.
- 8.2. **Appointment.** The Director shall be an employee of Jasper County.

- 8.3. **Employees.** In accordance with the prescribed procedures of this jurisdiction, Jasper County Board of Supervisors shall have the authority to hire employees. Such employees shall have powers as delegated by the Director.
- 8.4. **No Warranty, Expressed or Implied.** No warranty, expressed or implied, is granted to any owner of any OWTS by Jasper County, its boards, or employees, by enforcement of this ordinance.

# 9. DUTUES AND POWERS OF THE DIRECTOR

- 9.1. **General.** The Director is hereby authorized and directed to enforce the provisions of this ordinance. The Director shall have the authority to render interpretations of this ordinance, and to adopt policies, procedures, rules, and regulations in order to clarify the application of its provision. Such interpretations, policies, procedures, rules, and regulations shall be in compliance with the intent and purpose of this ordinance. Such policies and procedures shall not have the effect of waiving requirements specifically provided for in this ordinance.
- 9.2. Rule-making authority. The Director shall have authority as necessary in the interest of public health, safety, and general welfare, to adopt the promulgate rules and regulations and to designate requirements. Such rules shall not have the effect of waiving requirements specifically provided for in this ordinance, or of violating accepted engineering methods involving public safety.
- 9.3. **Applications and permits.** The Director is authorized to receive applications, review installation documents and issue permits for the installation of OWTS, inspect the premises for which such permits have been issued and enforce compliance with the provisions of this ordinance.
- 9.4. **Notices and orders.** The Director is authorized to issue all necessary notices or orders as are required to effect compliance with this ordinance.
- 9.5. **Inspections.** The Director shall make all the inspections necessary to determine compliance with the provision of this ordinance.
- 9.6. **Right of entry.** The Director is authorized to enter the structure or premises at reasonable times to inspect or perform the duties imposed by this ordinance.
- 9.7. **Department records.** The Director shall keep official records of applications received, permits and certificates issued, fees collected, reports of inspections, notices and orders issued, and as required by this ordinance, such records shall be retained in the official records for the period require for retention of public records.
- 9.8. **Approvals and modifications.** A record of approvals and modifications granted shall be maintained by the Director and shall be available for public inspection during business hours in accordance with applicable laws.
- 9.9. Alternative methods or materials. The application for modification, alternative methods or materials and the final decision of the Director shall be in writing and shall be officially recorded in the permanent records of the Director.
- 9.10. Liability. The Director or employee charged with the enforcement of this ordinance, while acting for the jurisdiction in good faith and without malice in the discharge of the duties required by this ordinance or other pertinent law or ordinance, shall not thereby be rendered liable personally, and is hereby relieved from all personal liability for any damage accruing to persons or property as a result of any act or by reason of an act or omission in the discharge of official duties. Any suit instituted against any officer or employee because of an act performed by that officer or employee in the lawful discharge of duties and under the provision of this ordinance shall be defended by the legal representative of the jurisdiction until the final termination of the proceedings, and the Director or any

subordinate shall not be liable for costs in any action, suit or proceeding that is instituted in pursuance of the provisions of this ordinance.

#### 10. PERMITS

- 10.1 **Permits Required.** Anyone who desires to install, alter, or repair an OWTS regulated by this ordinance, or to cause such work to be done, shall first make application to the Director and obtain the required permit for the work. It shall be a violation of this ordinance to commence any work on any OWTS without a permit. Fees will be doubled if work is started prior to obtaining the required permits.
- 10.2 **Application**. Application for a permit required by this ordinance shall be made to the Director in such form and detail as prescribed by the Director. Applications for permits shall be accompanied by such plans as prescribed by the Director.
  - 10.2.1 Submittal documents include but are not limited to the following:
    - 10.2.1.1. A site analysis may be prepared by a Professional Licensed Engineer, the department employees or other qualified party approved by Jasper County Environmental Health. The Director shall have the right to not provide site analysis duties at his discretion. A soil assessment report is required to be included with the site analysis. A percolation test shall not be used in place of a soil assessment unless pre-approved by the Director. The site analysis will show that the system will meet all setbacks required by law.
    - 10.2.1.2. A design layout and component specifications, prepared by a Professional Licensed Engineer or licensed installer, acceptable to the Director. A Jasper County licensed installer or professional engineer may use the Administrative Authority's site analysis report as part of the design completion. The department shall not prepare any design layout or component specifications for any application.
    - 10.2.1.3. Documentation of maintenance provisions and NPDES permits if required.
    - 10.2.1.4. A recorded perpetual easement shall be required if any portion of an OWTS will be sited on property owned by anyone other than the owner of the property connected to the OWTS. It is the property owner's responsibility to obtain such perpetual easement prior to application or when division of land makes one necessary. The Director shall be provided with a copy of the recorded easement prior to issuing a permit to construct or completing a time of transfer inspection.
    - 10.2.1.5. Where special conditions exist, the Director is authorized to require additional documents deemed necessary to determine compliance with this ordinance.
    - 10.2.1.6. The Director is authorized to waive the submission of installation documents and other data not required if it is found that the nature of the work applied for is such that reviewing of installation documents is not necessary to determine compliance with this ordinance.
    - 10.2.1.7. Electronic media documents are permitted to be submitted where approved by the Director.
    - 10.2.1.8. Site Plan. A site plan showing the location of new installation and existing structures on the site, distances from lot lines, the proposed finished grades. The Director is permitted to waive or

modify the requirement for a site plan where the application for permit is for alteration or repair or where otherwise warranted.

- 10.3. **Action on application.** The Director shall examine or cause to be examined applications for permits and amendments thereto within a reasonable time after filing. If the application or the installation documents do not conform to the requirements of pertinent laws, the Director shall reject such application in writing, stating the reasons therefor. If the Director is satisfied that the proposed work conforms to the requirements of this ordinance and laws and ordinances applicable thereto, the Director shall issue a permit therefore as soon as practicable.
- 10.4. **Conditions of a permit.** A permit shall constitute permission to conduct work as set forth in this ordinance in accordance with the provision of this ordinance. Such permission shall not be construed as authority to violate, cancel or set aside any of the provisions to this ordinance or other applicable regulations or laws of the jurisdiction. Permits presuming to give authority to violate or cancel the provisions of this ordinance or other ordinances of the jurisdiction shall not be valid. The issuance of a permit based on installation documents and other data shall not prevent the Director from requiring the correction of errors in the installation documents and other data. The Director is also authorized to prevent use of an OWTS where in violation of this ordinance or of any other ordinances of this jurisdiction.
- 10.5. **Expiration.** Every permit issued shall become invalid unless the work on the site authorized by such permit is commenced within one year 6 months after its issuance, or if the work authorized on the site by such permit is suspended or abandoned for a period of ten days after the time the work is commenced.
- 10.6. **Extensions.** The Director is authorized to grant, in writing, one or more extensions for the time period of a permit. The length of the extension shall be set by the Director. Such extensions shall be requested by the permit holder in writing and justifiable cause demonstrated.
- 10.7. **Posting the permit**. Issued permits shall be kept on the premises designated therein at all times and shall be readily available for inspection by the Director.
- 10.8. **Information on the permit.** The Director shall issue all permits required by this ordinance on an approved form furnished for that purpose. The permit shall contain a general description of the work to be performed and its location and any other information required by the Director. Issued permits shall bear the signature of the Director.
- 10.9. **Suspension or revocation.** The Director is authorized to suspend or revoke a permit issued under the provisions of this ordinance wherever the permit is issued in error, based on incorrect, inaccurate or incomplete information; in violation of any ordinance, regulation or any of the provisions of this ordinance; or if any one of the following conditions exists:
  - 10.9.1. The permit is used for a location other than that for which it was issued.
  - 10.9.2. The permit is used for a condition or activity other than that listed in the permit.
  - 10.9.3. Conditions and limitations set forth in the permit have been violated.
  - 10.9.4. There have been any false statements or misrepresentations as to the material fact in the application for permit or plans submitted or a condition of the permit.
  - 10.9.5. The permit is used by a different person or firm than the name for which it was issued.
  - 10.9.6. The permittee failed, refused or neglected to comply with orders or notices duly served in accordance with the provisions of this ordinance within the time provided therein.

- 10.9.7. The permit was issued in error or in violation of an ordinance, regulation or this ordinance.
- 10.10. **Schedule of permit fees.** A fee for each permit shall be paid as required, in accordance with the current fee schedule as established by Jasper County **Environmental Health**. Board of Supervisors.
- 10.11. **Payment of fees**. A permit shall not be valid until the fees prescribed by law have been paid, not shall an amendment to a permit be released until the additional fee, if any, has been paid.
- 10.12. **Related fees.** The payment of the fee for the installation, alteration, or repair done in connection with, or concurrently with, the work authorized by a permit shall not relieve the applicant or holder of the permit from the payment of other fees that are prescribed by law.
- 10.13. **Refunds.** The Director is authorized to establish a fee refund policy.
- 11. Licensing of OWTS Installer/Contractors.
  - 11.1 **License Required.** No person shall install, alter, or repair any OWTS in Jasper County, lowa unless they have first obtained an OWTS Installers License by the Department.
  - 11.2 Licensing Requirements. Only individuals licensed by the State of Iowa as a Plumbing Contractor or Journeyman or certified by the National Environmental Health Association (NEHA) as a Certified Installer of Onsite Wastewater Treatment Systems (CIOWTS) shall be granted an OWTS Installers License by the Department.
  - 11.3 **Licensee required at Job site.** A licensed individual shall be on the job site during the entire period of installation, alteration, or repair of any OWTS and be available for consultation with Department staff.
  - 11.4. **License Revocation.** An OWTS Installers License may be revoked by Jasper County Environmental Health for violation of this ordinance or any other applicable laws or regulations.
    - 11.4.1. The licensee shall have the right to appeal the revocation of license by requesting an evidentiary hearing before the Jasper County Board of Supervisors prior to the revocation becoming effective. A representative of the Environmental Health Department shall be present at the hearing. Such hearing request shall be made in writing and delivered to the Director no later than ten days after the licensee is notified of the revocation.
  - 11.5. **License Reinstated.** No licensee shall be issued a new license within a period of twelve (12) months after the effective date of any revocation except on recommendation by Jasper County Environmental Health.
  - 11.6. **License Term.** An OWTS Installer License shall be valid for a period of time established by Jasper County Environmental Health.
  - 11.7. **License Fee.** A fee schedule for OWTS Installer Licenses shall be determined by Jasper County Board of Supervisors.

# 12. INSPECTIONS

- 12.1. **General.** The Director is authorized to conduct inspections that are deemed necessary to determine compliance with the provisions of this ordinance.
- 12.2. **Inspection requests.** It shall be the duty of the person doing the work authorized by a permit to notify the Director that such work is ready for inspection. It shall be the duty of the person requesting any inspections required by this ordinance to provide access to and means for inspection of such work.

- 12.3. Concealed work. Work shall remain accessible and exposed for inspection purposes until approved. It shall be the duty of the permit applicant to cause the work to remain accessible and exposed for inspection purposes. Wherever any installation subject to inspection prior to use is covered or concealed without having first been inspected, the ordinance official shall have the authority to require that such work be exposed for inspection. Neither the Director nor the jurisdiction shall be liable for expense entailed in the removal or replacement of any material required to allow inspection.
- 12.4. **Underground.** Underground inspection shall be made after trenches or ditches are excavated and bedded, piping, devices and equipment installed, and before backfill is put in place. Where excavated soil contains rocks, broken concrete, frozen chunks and other rubble that would damage the OWTS components protection shall be provided in the form of granular or selected material, or other means approved by the Director.
- 12.5. Other inspections. In addition to the inspections specified, the Director is authorized to make or require other inspections of any permitted work to ascertain compliance with the provisions of this ordinance and other laws, which are enforced by the department.
- 12.6. Final inspection. The final inspection shall be made after all work required by the permit is completed.
- 12.7. **Approval required.** Work shall not be performed beyond the point indicated in each successive inspection without first obtaining the approval of the Director. The Director shall either indicate the inspected portion of the installation is satisfactory as completed or shall notify the permit holder or an agent of the permit holder wherein the same fails to comply with this ordinance. Any portions that do not comply shall be corrected and such portion shall not be covered or concealed until reinspected and approved by the Director.
- 12.8. **Validity.** Approval as a result of an inspection shall not be construed to be an approval of a violation of the provisions of this ordinance or of other ordinances of the jurisdiction. Inspections presuming to give authority to violate or cancel the provisions of this ordinance or of other ordinances of the jurisdiction shall not be valid.
- 12.9. **Right of entry.** Where it is necessary to make an inspection to enforce the provisions of this ordinance, or where the Director has reasonable cause to believe that there exists in a structure or upon any premises a condition that is contrary to or in violation of this ordinance, which makes the structure or premises unsafe, dangerous or hazardous, the Director is authorized to enter the structure or premises at reasonable times to inspect or to perform the duties imposed by this ordinance, provided that if such structure or premises be occupied, that credentials be presented to the occupant and entry requested. If such structure or premises is unoccupied, the Director is authorized to first make a reasonable effort to locate the owner or other person having charge or control of the structure or premises and request entry. If entry is refused, the Director shall have recourse to the remedies provided by law to secure entry.
- 12.10. **Assistance from other agencies.** The assistance and cooperation of police, building, fire and health department officials and all other officials shall be available as required in the performance of duties.

#### 13. VIOLATIONS

13.1. **Violations** – The equitable owner of real property, and each person in possession thereof, who allows, creates, or maintains a violation of any provision of this ordinance on such property, shall be considered guilty of a county infraction. A county infraction is a civil offense punishable by a civil penalty of not more than seven hundred fifty (750) dollars for an initial violation or, if the infraction is a repeat offense, a civil penalty of not more than one thousand (1,000) dollars for each repeat offense, plus all costs, plus all other remedies allowable under the Code of lowa.

- 13.2. **Enforcement of Violations** All inspections and enforcement actions shall be conducted under the direction and supervision of the Director, who may seek the assistance of other public officers or employees to perform such duties as may be necessary to enforce the provisions of this ordinance.
- 13.3. Enforcement Procedures Service of notice and all other enforcement procedures involving any alleged violation of this ordinance shall be as set forth in Code of Iowa and applicable Rules of Court, as may be amended from time to time.
- 13.4. **Abatement Costs** All costs of abatement including, but not limited to, the costs for equipment, personnel, and any contract or day labor portions of such abatement shall be determined and fixed in accord with the definitions, values, and other requirements set forth under lowa Administrative Code and such requirements and costs are by this reference incorporated herein and made a part hereof, as may be amended from time to time. All other costs, fees, and expenses incurred involving abatement shall be calculated at the exact cost therefore initially borne borne by Jasper County, lowa in such enforcement endeavors.
- 13.5. Abatement Fund To better ensure ongoing enforcement of the provisions of this Regulation, Jasper County Environmental Health, through the office of the Auditor of Jasper County, lowa, shall at all times keep and maintain as part of its annual budget, a special fund to be known as the "Environmental Health Enforcement Fund". The fund will be annually appropriated by the Board of Supervisors such sums as are necessary to bring the balance in such fund up to the sum of twenty-five thousand dollars at the beginning of each fiscal year. Such fund may be used solely for the purpose of Environmental Health Regulations.
- 13.6. **Variances** Variances to these rules and regulations may be granted by the proper authority provided sufficient and proposed alternative information is afforded to substantiate the need and propriety for such action. Variances shall be requested in writing and addressed to the Jasper County authorized authority, the Environmental Health Director. All decisions regarding this topic shall be issued in writing to the requester.
- 13.7. Appeal Any person who feels aggrieved by any notice or order made by Jasper County Environmental Health or its authorized agent, shall have the right to appeal to Jasper County Environmental Health and Jasper County Board of Supervisors at the next regular Board of Supervisors meeting. The Jasper County Board of Supervisors by majority vote may modify, withdraw, or order compliance with said notice or order.

14. WHEN EFFECTIVE. This ordinance shall be effective after its final passage, approval and publication as provided by law

#### 1.01 POLICY

Jasper County Animal Control will maintain licensure as a "pound" under the Bureau of Animal Industry in the Dept. of Agriculture and Land Stewardship. Jasper County Animal Control will conduct activities that support chapter 717 and 717B of the Code of Iowa as it relates to offenses and injury to animals. This will be done in cooperation with local law enforcement. Fees may will be charged to cover costs of disease prevention and custodial care.

#### 1.02 DEFINITIONS

For use in this chapter, the following terms or words are interpreted or defined:

- 1. "Animal" means domesticated dog or cat unless otherwise indicated in this section.
- 2. "Animal Control Officer" means a person designated by the county to perform such duties involving animal control and having police authority for the enforcement in this chapter.
- **3.** "Animal Pound" means any premises, either designated or contracted for, by the county for the proper care of impounded animals held under the authority of this chapter.

- 4. "At Large" means any animal found off the premises of its owner and not under the control of a competent person. An animal shall not be deemed at large if such animal is:
  - A. Restrained within a motor vehicle.
  - **B.** In a fenced-in area.
  - C. Housed in a veterinary hospital or kennel.
  - **D.** On a leash (electronic or otherwise).
  - E. "At heel" beside a competent person and obedient to that person's command.
- 5. "Attack" means an act committed by an animal with the ability to execute such an act that either by threat of physical contact or actual physical contact causes fear, pain or injury to a human being or an animal so long as the latter has not first committed such an act on the offending animal.
- 6. "Cats" means both male and female animals of the feline species, whether altered or not.
- 7. "Control" is established when an animal is secured by a leash or lead, confined in a fenced-in area or vehicle, or obedient to a competent person's commands.
- 8. "County Agent" is the director of community development or designee.
- 9. "Dangerous Animal" means (a) any animal which is not naturally tame or gentle, and which is of a wild nature or disposition, and which is capable of killing, inflicting serious injury upon, or causing disease among, human beings or animals and having known tendencies as a species to do so; (b) any animals declared to be dangerous by the Board of Supervisors upon reasonable notice to the owner thereof who shall be entitled to a hearing before the Board; and (c) the following animals which shall be deemed dangerous animals per se:
  - A. Wolves, coyotes, and foxes;
  - B. Badgers, wolverines, weasels, mink, and other Mustelids;
  - C. Bats:
  - D. Bears:
  - E. Gila monsters and lizards that are venomous or poisonous;
  - F. All apes (including chimpanzees), baboons, and macaques;
  - G. Monkeys, except the squirrel monkey;
  - H. Elephants;
  - I. Wild boar;
  - J. Black widow and brown recluse spiders and scorpions;
  - K. Snakes which are naturally venomous or poisonous;
  - L. Snakes which are constricting and exceeding six (6) feet in length;

- M. All cats, except domestic cats (Carnivore of the family Felidae, including but not limited to lions, cougars, tigers, jaguars, leopards, lynx, ocelots, bobcats, etc.);
- N. Raccoons, opossums, and skunks;
- O. Any animal that has attacked or bitten any person without provocation, or any animal that has exhibited vicious propensities in present or past conduct by acting in the following manner; (a) by biting a person or persons on two separate occasions within a twelve (12) month period; or (b) did bite a person once causing injuries above the shoulders of the person.
- 10. "Disturbance" means the act of trespassing, chasing, maiming, or killing domestic livestock or fowl; damaging or killing domestic livestock or fowl; damaging or destroying personal property; biting or attempting to bite a person.
- 11. "Dogs" means both male and female animals of the canine species, whether altered or not.
- 12. "Impound animal" means an animal that is taken or seized by police action.
- 13. "Livestock" means animals kept for use of pleasure, especially farm animals kept for use and profit including fowl.
- 14. "Owner" includes, in addition to its ordinary meaning, any person or persons, firm, association or corporation owning, keeping, sheltering or harboring an animal.
- 15. "Potentially dangerous dog" means any of the following:
  - A. Any dog which, when unprovoked, on two separate occasions within the prior 36-month period, engages in any behavior that requires a defensive action by any person to prevent bodily injury when the person and the animal are on or off the property of the owner or keeper of the dog.
  - **B.** Any dog which, when unprovoked, inflicts injury upon a person less severe than as defined in Section 1.02(9).
- 16. "Proper enclosure" means any pen or kennel with sides attached to a secured top and a secured bottom, floor or foundation. In lieu of a top, a fence may be used that is at least six feet in height or six feet taller than any internal structure that the dog can jump from. In lieu of a bottom, a fence may be used that is imbedded into the ground at least two feet to prevent any digging under the fence.
- 17. "Provoked" means, but is not limited to:

- **A.** Any willful trespass or other tort upon premises occupied by the owner or keeper of the dog.
- **B.** Any act of teasing, tormenting, abusing, or assaulting or threat to act; being committed by a person or animal against a dog or the owner or keeper of the dog.
- 18. "Severe injury" means any physical injury to a human being that results in muscle or tendon tears, joint injuries, disfiguring lacerations or requires multiple sutures.
- 19. "Stray" means any animal unlawfully running at large, the ownership of which cannot with reasonable investigation be ascertained or any animal which has been abandoned by its owner.
- **20.** "Unincorporated Areas" means areas not within the confines of an incorporated city.
- 21. "Vicious dog" means any of the following:
  - **A.** Any dog, which, when unprovoked and in an aggressive manner, bites a human being above the waist (excluding the hands) or inflicts severe injury upon or kills a human being.
  - **B.** Any dog previously determined to be potentially dangerous by Jasper County which, after its owner or keeper has been notified of the determination, described in Section 1.02 continues the behavior described or is maintained in violation of Section 1.08.

## 1.03 INTAKE/ RELEASE PROCEDURE

- **A.** Animals will be impounded by a county agent or the local law enforcement officer at their discretion if the animal poses a safety threat to the community.
- **B.** Animals that are claimed by an owner must be shown to be current on their Rabies, Distemper/Parvo vaccination before they can be released. No animal may leave the facility without a Rabies certificate, and Distemper/Parvo vaccinations.
- C. An "Animal Release Form" must be filled out for all animals held in the pound and held on file for one year as per State licensing requirements. for a pound.
- **D.** Animals that are known to be potentially dangerous, dangerous, vicious, or having a contagious disease may not be admitted into the pound's custody.

#### 1.04 UNCLAIMED ANIMALS

- **A.** Stray animals brought to the pound that have not been claimed after 7 days will be transferred to another animal rescue facility. All information known about the animal shall be disclosed to the animal rescue facility by pound staff.
- **B.** Stray animals will be given Distemper/Parvo, Bordetella, and Rabies vaccinations according to Iowa Department of Agriculture and Land Stewardship (IDALS) regulation.

- C. Impound animals that have been acquired by police action, not claimed within 72 hours may be transferred to an animal rescue facility. All information known about the animal shall be disclosed to the animal rescue facility by pound staff or local law enforcement. Police Authority shall notify the animal owner that their animals were seized and that they have 72 hours to properly get their animals out of impound or make approved arrangements with pound staff.
- **D.** Animals deemed to be not adoptable due to health or temperament by a licensed veterinarian will be humanely euthanized by a licensed veterinarian.

# 1.05 RESPONSIBILITY OF OWNERS

It shall be the responsibility of an owner of any animal, through the use of methods deemed reasonable and proper and in accordance with all other laws, to comply with the following conditions:

- 1. It is unlawful for an owner of any animal to permit such animal to pass upon the premises of another person, thereby causing damage to, or interference with, the premises.
- 2. It is unlawful for an owner of any animal to permit such animal to cause serious noise or disorder to any person or persons by frequent and habitual howling, yelping, barking, or otherwise; or by running after or chasing persons, bicycles, automobiles or other vehicles, or in any way posing a public hazard, a public nuisance, or a disturbance.
- 3. It shall be the duty of the owner of any dog, cat or other animal which has bitten or attacked a person or any person having knowledge of such bite or attack to report this act to a local health or law enforcement official. It shall be the duty of physicians and veterinarians to report to the Board of Health, County Agent, or Local Law Enforcement the existence of any animal known or suspected to be suffering from rabies. (Code of Iowa, Sec. 351.38)

# 1.06 CONDITIONS FOR IMPOUNDMENT

- 1. Any animal found at large that may pose a safety threat.
- 2. Any dog which is causing a disturbance is subject to seizure and impoundment.
- **3.** Any vicious dog or dangerous animal believed to pose a risk or threat of harm to any person or animal may be seized and impounded.
- **4.** Any animal against which two (2) or more complaints for running at large and causing a disturbance to have been made is subject to restraint on the property of the owner. This is to include all animals within the County.

5. Any animal that is seized by police action.

#### 1.07 CONFINEMENT

When the Animal Control Officer or County Agent receives information that any person has been bitten by an animal or that a dog or animal is suspected of having rabies, the Animal Control Officer or County Agent shall order the owner to confine such animal in the manner provided herein for a minimum of ten (10) days.

- 1. An animal must be quarantined by a licensed veterinarian or at a licensed pound at the owner's expense, if:
  - A. The animal, over four (4) months of age, has no record of current rabies vaccination. Unvaccinated animals cannot be vaccinated until the end of the quarantine period, at which time the animal must be vaccinated at the owner's expense and paid in advance of the 10-day hold.
  - **B.** The events leading to the incident are such that rabies is suspected.
  - C. There was no due cause for the incident, or the animal has suspicious recent history. This will be utilized even if the animal has a record of being currently vaccinated for rabies.
- 2. Home quarantine may be permissible if:
  - **A.** Conditions listed in Subsection 1.07 (1) are not applicable and the owner can provide proper confinement of the animal, complete with the posting of a sign in a conspicuous place, warning of possible rabies infection. Confinement will be done by the penning of the animal so that there is a metal barrier as to prevent the intimate approach of any other animal or person.
  - **B.** The owner of the animal shall sign an agreement to adhere to the rules of confinement for the designated length of time, and also agrees to notify the County immediately if the animal sickens, dies, or escapes.
  - C. The animal must be examined by a licensed veterinarian at the end of the quarantine period, and revaccinated if the bite occurred within two months of the expiration date of the current vaccination. The quarantine period shall be ten (10) days for all animals. With the approval of a licensed veterinarian, said animal may be euthanized and the brain sent for examination at the owner's expense, if it is not practical to confine the animal for reasons of health and safety. If the owner fails to confine such animal in the manner directed, and animal shall be apprehended and impounded and after ten (10) days the animal will be euthanized. If such animal is returned to its owner, the owner shall pay the cost of impoundment and any other costs associated with the care of the animal.

# 1.08 KEEPING OF POTENTIALLY DANGEROUS DOGS

A potentially dangerous dog shall at all times be kept confined within a residence or in a secured proper enclosure. The enclosure shall be locked with a key or combination lock to prevent the entry of children. When off the premises, the dog must be kept on a

substantial leash of no more than six feet in length and under the control of a responsible adult. If there are no additional instances of the behavior described in Section 1.02 within a 36-month period from the date of designation as a potentially dangerous dog, the dog may be removed from the list of potentially dangerous dogs.

# 1.09 RIGHT TO KILL

The County reserves the right to euthanize any animal not under observation for rabies or under rabies quarantine for which no reasonable veterinary care would prove to be practical to sustain said animal, when said animal is afflicted with a contagious disease which would endanger the welfare of the other animals in the shelter, or any dog declared as vicious by Jasper County.

# 1.10 KEEPING OF VICIOUS DOGS AND DANGEROUS ANIMALS PROHIBITED

No person shall keep, shelter or harbor any animal as a pet, or act as a temporary custodian for such animal, or keep, shelter or harbor such animal for any other purpose or in any other capacity within the County except as provided in Section 1.11 of this chapter. No dog declared as vicious shall be allowed to be taken out of or brought into Jasper County.

# 1.11 VICIOUS DOGS AND DANGEROUS ANIMAL EXCEPTIONS

The prohibition contained in Section 1.10 of this chapter shall not apply to the keeping of illegal animals in the following circumstances:

- 1. The keeping of illegal animals in a public zoo, bona fide educational or medical institution, humane society or museum where they are kept as live specimens for the public to view, or for the purpose of instruction, research or study.
- 2. The keeping of illegal animals for exhibition to the public by a bona fide traveling circus, carnival, exhibit or show.
- 3. The keeping of illegal animals in a bona fide, licensed veterinary hospital for treatment.
- **4.** The keeping of illegal animals by a wildlife rescue organization with appropriate permit from the Iowa Department of Natural Resources.
- 5. Dogs while utilized by any law enforcement officer in the performance of enforcement work.

# 1.12 ABATEMENT PROCEDURES PERTAINING TO VICIOUS DOGS AND DANGEROUS ANIMALS

If the County Agent has a reasonable suspicion that a dog is vicious, or a dangerous animal is in violation of this chapter, the County Agent shall conduct or cause to be conducted, an investigation. In the event that the County Agent has probable cause to believe that a dog is

vicious, or a dangerous animal is in violation of this chapter, the County Agent shall be empowered to convene a hearing for the purpose of determining whether or not the dog in question should be declared vicious or the dangerous animal is in violation and constitutes a hazard.

If a hearing is to be convened, the County Agent shall notify the owner or keeper of the vicious dog or dangerous animal that a hearing will be held at which said owner or keeper may have the opportunity to present evidence why the dog or dangerous animal shall not be declared a hazard.

The hearing shall be held promptly within no less than five (5) days or more than ten (10) days after the service of notice upon the owner or keeper of the dog or dangerous animal. The hearing shall be informal and shall be open to the public.

The hearing shall be overseen by a three (3) person committee. Members of the committee shall have two-year appointments and the committee shall consist of one member being an employee from the Jasper County's Sheriff's Office, one member being a licensed veterinarian, and one member being a Jasper County resident.

After the hearing, the owner or keeper of the dog or alleged dangerous animal shall be notified in writing of the determination. If a determination is made that the dog is vicious or the dangerous animal is a hazard; the owner or keeper shall comply with the provisions of this chapter in accordance with a time schedule established by the County Agent, but in no case more than thirty (30) days subsequent to the date of determination. If the owner or keeper of the dog or dangerous animal contests the determination, he or she may bring a petition in the district court within the judicial district wherein the dog or dangerous animal is kept, praying that the court conduct its own hearing on whether or not the dog be declared vicious or the dangerous animal be found to be in violation and a threat to the public safety. After service of notice upon the County Agent, the court shall conduct a hearing anew and make its determination as to alleged viciousness or hazard. The issue shall be decided upon the preponderance of the evidence.

If the court rules the dog to be vicious, or the dangerous animal to be a threat to the public safety, the court may establish a time schedule to ensure compliance with this chapter. The court may decide all issues for or against the owner or keeper of the dog or dangerous animal, regardless of the fact that said owner or keeper fails to appear at said hearing. The determination of the district court shall be final and conclusive upon all parties thereto. However, the County Agent shall have the right to declare a dog vicious or an animal dangerous for any subsequent actions of the dog or animal. In the event that the County Agent has probable cause to believe that the dog in question is vicious or the animal is dangerous and poses a threat of serious harm to human beings or domestic animals, the County Agent may seize and impound the dog or dangerous animal pending the aforesaid hearings. The owner or keeper of the dog or dangerous animal shall be liable to the County when the dog or dangerous animal is impounded for costs and expenses of keeping such dog or dangerous animal.

### 1.13 ANIMAL WELFARE AND CARE

All animals shall be maintained with a "minimum level of care." This shall mean the care sufficient to reasonably preserve the physical health and condition of the animal(s), and except for emergencies or circumstances beyond the reasonable control of the owner includes but is not limited to the following requirements:

- 1. A quantity of wholesome feed suitable for the animal's species and age, sufficient to maintain reasonable levels of nutrition, at intervals or not more than twenty- four (24) hours or longer if the dietary requirements of the animal require.
- 2. Reasonable access to a supply of clean, fresh water provided for drinking in amounts and at intervals suitable for the species, not to exceed twenty-four (24) hours at any interval.
- 3. If the animal is a pet, adequate access to a shelter sufficient to ensure that the pet does not suffer unreasonable distress due to natural elements, including but not limited to wind, rain, snow, sun, cold, heat, or dampness.
- **4.** If the animal is livestock, adequate access to a natural or constructed barrier sufficient to offer reasonable protection against temperature extremes, wind, rain, or snow.
- 5. If the animal is restricted in a confinement area for an extended period, the area shall be kept reasonably clean and free from contaminates, including animal waste, which may threaten the health of the animal.
- 6. Veterinary or farrier care, if a reasonably prudent person would advise such care to relieve distress from injury, disease or neglect.
- 7. If the animal is a pet, a confinement area with adequate space for the exercise necessary to preserve the health of the animal and which provides a dry area for the animal to rest. The air temperature or ventilation in the confinement area shall be suitable to preserve the health of a normal animal of the same species.
- 8. If an animal is fastened by a leash, including a rope or chain, which restricts the movement of the animal, a leash shall be attached to the animal by a well-fitting collar or harness that is fastened to the animal in a manner designed to prevent injury or entanglement. A leash shall not restrict an animal from access to adequate shelter or sufficient food or water.

# 1.14 ANIMAL WELFARE COMPLAINTS

A. If a complaint is received about an animal's welfare or a neglect situation, the ACO will investigate following the Iowa Code Chapter 717 and 717B for guidance.

- **B.** Following a complaint, the ACO will fill out a complaint form, documenting the caller contact information if available, and all steps taken to investigate and/or remediate the situation. The owner of the property and/or animal(s) of concern will then be contacted to ask permissions to check on the welfare and condition of the animal(s). If given permission the ACO will observe the living conditions and requirements of the law for the species of concern.
- C. If permission to investigate is denied by the owner, law enforcement will be contacted for procedure to gain admittance to investigate. If necessary, a search warrant may be requested by law enforcement from the county attorney. Further investigations from a search warrant will be done according to law and Chapter 717 and Chapter 717B.

# **1.15 FEES**

The Jasper County Board of Supervisors will establish fees to be collected by Jasper County Animal Control for services necessary for carrying out provisions of this article.

# 1.16 VIOLATIONS

- 1. Violations The equitable owner of real property, and each person in possession thereof, who allows, creates, or maintains a violation of any provision of this ordinance on such property, shall be considered guilty of a county infraction. A county infraction is a civil offense punishable by a civil penalty of not more than seven hundred fifty (750) dollars for an initial violation or, if the infraction is a repeat offense, a civil penalty of not more than one thousand (1,000) dollars for each repeat offense, plus all costs, plus all other remedies allowable under the Code of Iowa.
- 2. Enforcement of Violations All inspections and enforcement actions shall be conducted under the direction and supervision of the Director, who may seek the assistance of other public officers or employees to perform such duties as may be necessary to enforce the provisions of this ordinance.
- 3. Enforcement Procedures Service of notice and all other enforcement procedures involving any alleged violation of this ordinance shall be as set forth in Code of Iowa and applicable Rules of Court, as may be amended from time to time.
- 4. Variances Variances to these rules and regulations may be granted by the proper authority provided sufficient and proposed alternative information is afforded to substantiate the need and propriety for such action. Variances shall be requested in writing and addressed to the Jasper County authorized authority, the Community Development Director. All decisions regarding this topic shall be issued in writing to the requester.
- 5. Appeal Any person, who feels aggrieved by any notice or order made by Jasper County Animal Control or its authorized agent, shall have the right to appeal to Jasper County Animal Control and the Jasper County Board of Supervisors at the next regular Board of

Supervisors meeting. The Jasper County Board of Supervisors by majority vote may modify, withdraw, or order compliance with said notice or order.

# 1.17 SEVERABILITY

If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjunction shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

# 1.18 EFFECTIVE DATE

This ordinance shall be in effect after its fin	al passage, approval and publication as

# Memorandum of Understanding

# The Jasper County Jail

# For the Provision of Specialty Clinic Telehealth

# **PURPOSE**

This Memorandum of Understanding (MOU) will establish an agreement for the delivery of Telehealth Services provided by the VA Central Iowa Health Care System hereafter referred to as the *Providing Facility*, to eligible Veterans when the Veteran is physically located within the Jasper County Jail, hereafter referred to as the Receiving Facility, and the provider is located within the VA facility (Providing Facility). This MOU will define respective roles and responsibilities, including fostering an environment that meets both federal and state expectations. Program elements outlined within this MOU have been mutually agreed upon between the *Providing Facility* Director and the *Receiving Facility* Administrator. This MOU will assist in providing consultative specialty services and other services mutually agreed upon from the *Providing Facility* to the *Receiving Facility* through the use of Telehealth technology. This MOU will also assist in allowing the Receiving Facility to screen patients for admission into the Receiving Facility when the patient is located within the *Providing Facility*. This MOU does not include the provision of any care required to be provided by the *Receiving Facility* under 38 CFR 51. This MOU does not change, modify, or supersede the established processes for scheduling outpatient appointments at the **Providing Facility** for services not offered via Telehealth or initiating requests for inpatient hospitalizations. The *Providing Facility* Director and *Receiving* Facility Administrator approval signatures indicate concurrence on the content, validity, and practicality of the services set forth in this document.

#### **BACKGROUND**

The *Receiving Facility* has Veteran residents who are enrolled in the VA healthcare system that require services, which the *Receiving Facility* is not required to provide, that could be provided by the *Providing Facility* via Telehealth. At the request of the Veteran, the *Providing Facility* agrees to provide consultative services delivered through the use of Telehealth technology when the services are available and deemed appropriate by the clinicians providing the service.

The VHA Handbook (1100.19, 11/14/2008) defines terms as follows:

- Teleconsulting is "the provision of advice on a diagnosis, prognosis, and/or therapy
  from a licensed independent provider to another licensed independent provider using
  electronic communications and information technology to support the care provided
  when distance separates the participants and where hands-on care is delivered at the
  site of the patient by a licensed independent health care provider."
- Telemedicine is "the provision of care by a licensed independent health care provider that directs, diagnoses, or otherwise provides clinical treatment delivered using electronic communications and information technology when distance separates the provider and the patient."

The VHA Handbook notes that "a crucial consideration in making a distinction between consultation and care is that teleconsultation occurs when the consultant involved recommends diagnoses, treatments, etc., to the consulting provider requesting the consult, but does not actually write orders or assume the care of the patient. If the consultant diagnoses, writes orders, or assumes care in any way, this constitutes "care" and requires privileges."

The Joint Commission defines Telehealth as follows: "The use of medical information exchanged from one site to another via electronic communications for the purpose of improving the health of the patient, the education of the patient or health care provider, or for the purpose of improving patient care."

Videoconferencing, transmission of still images, e-health including patient portals, remote monitoring of vital signs, continuing medical education, and nursing call centers are all considered venues for providing Telehealth. Telehealth is not a separate medical specialty. Products and services related to Telehealth are often part of a larger collection of healthcare services offered by health care institutions to enhance the delivery of clinical care. The provision of Telehealth services, as detailed in this inter-local agreement, supports the VHA's strategic goal of becoming a more patient-centered organization. Telehealth is an important component in the efforts to improve patient access to care, continuity of care, and Veteran satisfaction.

#### SCOPE

This MOU covers the delivery of Telehealth specialty services provided by the **Providing Facility** when the Veteran is physically located within the **Receiving Facility** and the provider is located within the **Providing Facility**. The scope for individual services provided must be included in a service specific Telehealth Service Agreement (TSA). This MOU does not include the provision of any care required to be provided by the **Receiving Facility** under 38 CFR 51.

# **RESPONSIBILITES OF THE PARTIES**

# Responsibilities of the Providing Facility and Receiving Facility

- 1. Confirm all appropriate and necessary resources are in place to support the agreed upon provisions of services including space, bandwidth, staffing, equipment, support services (including Information Technology), and clearly identified emergency response processes and personnel.
- 2. Comply with all applicable laws, regulations, and IT security mandates, including, but not limited to:
  - a. VHA Handbook 1100.19, Credentialing and Privileging (including amendments).
  - b. VACO, VISN and Facility telehealth specific policies and procedures
- 3. Assure compliance with Memorandum of Understanding for Telehealth Credentialing and Privileging.
- 4. Assure completion of Telehealth Service Agreement (TSA) for each service provided.
- 5. Be responsible and accountable for ensuring compliance with all VHA Telehealth standards for Conditions of Participation.
- 6. Be responsible and accountable for meeting accreditation standards for the provision of relevant services.
- 7. Communicate need for Telehealth service via phone/email and coordinate scheduling and any needed resources. Both facilities will strive to complete the patient appointment within 30 days of request.
- 8. The *Receiving Facility* will provide the *Providing Facility* with necessary and appropriate information when requesting services (referrals and consultations). Pertinent information may include, but not limited to, reason for request, relevant medical history, urgency, and other information deemed necessary to ensure timely and appropriate performance of Services. Information to be included will be determined and agreed to by providers of the *Providing Facility* and the *Receiving Facility* and specified in the Telehealth Service Agreement
- 9. Collaborate in the coordination of all relevant procedures and policies necessary for care delivery including, but not limited to, provider credentialing and privileging, TSAs, sharing of pertinent health record information, and compliance with all Health Insurance Portability and Accountability Act (HIPPA) requirements and any other reasonable requirements not included in this agreement.
- 10. Ensure all staff is appropriately trained to conduct Telehealth visits based on training programs at the respective facilities.

- 11. Providing all necessary on-site supervision of staff supporting the delivery of these services. These will include, but not be limited to, provision of medications, conducting special studies, providing procedure support, and other requirements as may be defined in the Telehealth Service Agreement. Each facility is responsible for assuring competencies of support personnel, as well as managing human resource requirements for support personnel
- 12. Be responsible for ensuring that each encounter is documented in the appropriate medical record and meets all health information and Telehealth coding requirements. The *Providing Facility* provider will be responsible for documentation in the VA Computerized Patient Record System (CPRS). Both parties are responsible for making available all access to relevant medical records and health information systems.
- 13. In the event there should be an interruption to the Telehealth services made possible by this MOU and as defined in the Telehealth Service Agreement, the *Providing Facility* and the *Receiving Facility* agree to take immediate and appropriate measures to ensure the patient continues to receive needed care/services in a manner consistent with VHA patient safety and healthcare standards.
- 14. Notify the other facility at the same time the staff of the source station is notified of any pending VISTA, PACS, and/or VA WAN or other connectivity interruptions that have an impact on providing or documenting patient care via telehealth technologies. If an interruption is scheduled, it will be scheduled in a manner that is least disruptive to patient care.
- 15. The parties will hold quarterly meetings to monitor the efficacy of the MOU. These meetings will be attended by staff from both facilities.

### **CREDENTIALING AND PRIVILEGING**

The process of Credentialing and Privileging ensures the quality of care delivered and reduces the risk to patients for adverse outcomes, by completing an appropriate assessment of staff, and potentially reduces the risk for liability exposure for the facility and Agency.

Credentialing and Privileging (VHA Handbook 1100.19) delineates authorized procedure regarding credentialing and privileging in VHA. This Handbook also allows for Credentialing and Privileging of Telehealth providers by proxy, if specific policy and procedure is followed. For specific Telehealth Guidance please see the link to the Telehealth Credentialing and Privileging PowerPoint.

### INFORMED CONSENT AND PRIVACY

Providing Facility and the Receiving Facility shall comply with all applicable laws and regulations including, without limitation, laws and regulations concerning patient records and the Health Insurance Portability and Accountability Act of 1996 (HIPAA). Verbal informed consent for Telehealth will be obtained by the Providing Facility provider and documented in the Veterans Affairs Computerized Patient Record System (CPRS) medical record at the beginning of the first Telehealth visit. Informed consent for Telehealth services need not be obtained for subsequent Telehealth visits with the same clinician. The Veteran has the right to refuse Telehealth at any time and receive care face to face.

If permanent video or photographic recording is used during the Telehealth session, then VA form 10-3203, Consent for Use of a Picture or Voice, must be used and written consent obtained from the patient.

### **QUALITY MANAGEMENT AND RISK MANAGEMENT**

Effectiveness in meeting healthcare needs will be delineated in the Telehealth Service Agreement (TSA). At a minimum, timeliness of services provided and patient satisfaction will be monitored. Both parties have responsibility to notify the other by telephone or email when there are issues, concerns or problems related to data/information transmissions, patient identification questions, confidentiality, incomplete information or patient safety.

Non emergent issues, concerns or problems related to patient safety, patient care, administrative concerns, data/information transmissions, patient identification questions, confidentiality, incomplete information, or other concerns affecting patient care, will be referred to the Facility Telehealth Coordinator and/or the Facility Patient Safety Officer at both *Providing* and *Receiving Facility*, for resolution.

If an adverse event (sentinel event and/or major complication or death) occurs, the first facility to become aware of the event will follow local policy/procedure for such an event and will notify the partnering facility so that procedures for such events can be followed at both facilities.

### FINANCIAL RENUMERATION

This is a non-reimbursable agreement between the *Providing Facility* and *Receiving Facility*. The Veteran patient may be responsible for a copay for each specialty visit depending upon the individual Veteran's copay eligibility.

### **EMERGENCY PROCEDURES AND SAFETY**

The Telehealth Service Agreement (TSA) will detail points of contact and emergency procedures to be followed for each specialty service provided. The *Receiving Facility* will follow all local emergency and safety procedures in the event of an emergent situation.

### MEDICAL DOCUMENTATION

All required medical record documentation by the provider will occur in the Veterans Affairs CPRS medical record. A technical solution is being examined to facilitate sharing of CPRS documentation, however it is anticipated that manual transfer via secure scan, email and/or fax may be required.

**Receiving Facility** staff will be responsible for documentation of the visit in the **Receiving Facility** medical record.

### **INFORMATION TECHNOLOGY & SECURITY**

The Providing Facility and Receiving Facility will coordinate regarding IT connectivity, identifying a Telehealth/IT point of contact at each site to establish and test connectivity. Each site will comply with all applicable laws, regulations and IT security mandates. Each site will be responsible for supplying and maintaining equipment utilized at their site for the Telehealth visit.

Facilities shall maintain compliance with all VA mandated rules for Patient Privacy, Information Security, Intranet Security and Internet Security. All staff, whether federal or vendor contractors, must complete all mandated security screening prior to obtaining permissions to access and utilize VA information systems.

### **EFFECTIVE DATE**

This agreement is effective upon signature by the *Providing Facility* Director and the *Receiving Facility* Administrator.

### **DURATION AND TERMINATION**

The agreement shall remain in effect until it is superseded by a subsequent written agreement between the parties; however, either party may cancel this agreement for any reason by giving thirty (30) days written notice of the cancellation. This agreement may be cancelled at any time by mutual consent of the parties concerned.

### **MODIFICATION AND AMENDMENT**

Modifications or amendments to this agreement shall be in writing and duly executed by the *Providing Facility* Director and the *Receiving Facility* Administrator.

### LIABILITY

In the event a claim or lawsuit is filed which alleges negligent acts or omissions by an individual acting under this agreement, the individual's employing agency shall be responsible for processing the claim or suit. Each agency agrees to cooperate in the investigation and defense of any claims for damages.

### ENTIRE UNDERSTANDING

This agreement, describing the provision of Telehealth services by *Providing Facility* providers to Veterans physically located at the *Receiving Facility*, contains all of the terms and conditions as understood by the parties. No other understandings, oral or otherwise, regarding the subject matter of the agreement shall be deemed to exist or bind either of the parties hereto. All parties to this agreement concur with the level of support and resource commitments that are documented herein.

The undersigned hereby execute this MOU on behalf of their respective parties.

### **Interfacility Telehealth Service Agreement**

**PURPOSE OF THIS DOCUMENT:** The Interfacility Telehealth Service Agreement (TSA) defines the clinical, technical, and business requirements for a clinical telehealth service when the distant and originating sites are not hosted under the same station identifier code (e.g., Medical Center A, Station 111 to Medical Center B, Station 222). It contains the information needed to operate telehealth services effectively and safely between sites. The contents of this service agreement only apply to virtual care services and do not apply to in-person care.

Credentialing and Privileging: VHA Directive 1914 Telehealth Clinical Resource Sharing Between VA

Facilities and Telehealth from Approved Alternative Worksites enables VA medical facilities to share health care professional (HCP) services through telehealth within the integrated VHA enterprise without re-credentialing or re-privileging the health care professionals at each VA medical facility or developing a Telehealth Memorandum of Understanding (MOU) between collaborating VA medical facilities.

However, if the facility provides telehealth services to a non-VA location, this still requires an MOU.

Comprehensive information regarding this directive can be found in VHA Telehealth Services 1914.

The Distant Medical Facility ensures that each health care professional's profile, i.e., Focused Professional Practice Evaluation (FPPE) and Ongoing Professional Practice Evaluation (OPPE), substantiates the health care professional's continued competency, and it supports their requested clinical privileges, functional statement, or scope of practice. The health care professionals' practice review (i.e., FPPE and OPPE reviews) and a copy of the health care professionals' privileges, the scope of practice, or functional statement are made available to an originating site upon request.

Each facility is encouraged to consult legal counsel regarding a cross-facility adverse or sentinel event. While distant sites provide oversight for the health care professional competency (i.e., OPPE and FPPE), the originating site provides any applicable feedback when identified through their usual processes from incidents, complaints, and other triggers regarding the episode of care provided by the telehealth health care professional.

### NOTES:

- 1. Unused information and checkbox items in the TSA template may be deleted to enhance readability once the TSA is finalized.
- 2. Where information may change (e.g., contact information, training requirements, participating health care professionals), it is recommended that links to alternate documents are placed in the TSA as opposed to the information itself.
- 3. One linked document with multiple sections (e.g., one document with a section for general contact information and another section for service-specific contact information) may be linked within





several sections of the TSA template to address related requirements. If providing links to a local SharePoint or repository, ensure these are accessible to all VA staff, including the Office of Connected Care Staff.

SUBJECT: Telehealth Emergency Response and Crisis Intervention Procedure

**PURPOSE:** To outline the management and process related to equipment and software failure for all staff providing telehealth services. The guidance below is to limit the impact of any one technology failure on patient care utilizing the best clinical judgment.

STANDARD OPERATING PROCEDURE: Staff will follow a consistent process in addressing equipment or software failures during telehealth appointments prioritizing patient safety. Staff will assess patient needs and coordinate clinically indicated alternatives or follow up care with the patient, patient site staff, or local services.

PROCEDURES: Below are common equipment and software failures. All procedures involve working with the Office of Information Technology (OIT), administrative staff, and local support to minimize the impact of patient care. For OIT issues, VA staff can contact Your IT Service Portal: <a href="https://yourit.va.gov/va">https://yourit.va.gov/va</a> and Enterprise Service Desk at (855) 673-4357. VA staff who need assistance with VA Telehealth and VA Mobile (apps and provider iPads) including VA Video Connect (VVC), and Veterans who need assistance with VVC should call the Office of Connected Care Help Desk (OCCHD). VA staff can submit tickets and check the status of tickets via the OCCHD web portal. For VA remote access information including Citrix Access Gateway (CAG), Cisco AnyConnect VPN, and telework tips, see <a href="https://www.oit.va.gov/resources/remote-access/">https://www.oit.va.gov/resources/remote-access/</a>.

### 1. Computerized Patient Record System (CPRS)

An interruption in CPRS access should not impact the provider's ability to see the patient. Below are the alternative access routes and potential scenarios.

- a. CPRS is down nationwide.
  - Access JLV to review history and medications: https://ilv.med.va.gov/JLV/.
  - Access Read Only CPRS via <a href="https://vistaro.central-iowa.med.va.gov/">https://vistaro.central-iowa.med.va.gov/</a>
  - Document in the standard note template either on paper or electronically.
  - Enter the note and any associated orders or consults when the system becomes available.
  - If you cannot access any part of the patient record, still see the patient to assess for safety and arrange a follow up.





- b. Alternate site CPRS icon has disappeared. Options include:
  - Go to the shared folder and copy a shortcut of the icon from the CPRS icon folder onto your desktop.
  - If applicable, use the VG launcher app in the VA shortcuts folder on your desktop or shared folder.
  - Open your internet browser and use CITRIX access (VA Shortcuts, National, Citrix) <a href="https://citrixaccess.va.gov/Citrix/StoreWeb/">https://citrixaccess.va.gov/Citrix/StoreWeb/</a>.
- c. CPRS is down on the provider side.
  - Document on the patient side.
  - Track which patients were impacted.
  - Document on the provider side when the system becomes available.
- d. CPRS is down on the patient side.
  - · Document on the provider side.
  - Track which patients are impacted. Inform the patient of any expected delays (entering medication or consults).
  - Document on the patient side when the system becomes available. Enter appropriate orders or consults.

### 2. Video Failure

- a. Main camera is out.
  - The main camera is generally either a Dx80/Ex90, web camera, or a laptop. Each provider will have a backup camera, including a laptop camera (if you have a Dx80), a free-standing webcam, or a working camera in another room.
    - If the main camera is out, please use the backup camera. The free-standing webcams will require a link via Virtual Care Manager. The link contains an address that a TelePresenter in the clinic can call directly into for the appointment.
- b. Both the main and the backup camera are out.
  - Please meet with the Veteran via telephone.
  - Enter an IT Help Desk ticket.
  - Bring your computer to the local IT Help Desk and inform the Facility Telehealth Coordinator (FTC) or administrative staff.

### 3. Audio Failure

- a. The camera is working but the patient cannot hear anything.
  - Attempt to use a backup camera.
  - If the local site has a telephone in the room, call the room and use it for audio while continuing the video. If the local site does not have a phone in the room and the Veteran has a phone, ask the Veteran if you can call his/her cell phone for audio while continuing video.





- Between sessions, test with a different receiver to determine if the problem was on the provider or patient side.
- If the patient side is the problem:
- Clinic Based Clinical Video Telehealth (CVT)
  - Ask the TelePresenter to contact their Facility Telehealth Coordinator (FTC) for support.
  - Ask to see additional appointments in another room.
  - Ask for a phone to be placed in the room for audio.
- CVT to home (via VA Video Connect)
  - Ask the patient to call the Office of Connected Care Help Desk (OCCHD) for support (1-866-651-3180).
  - Ask your FTC or designated staff to contact the Veteran for a test call to address the connection.
- If the provider side is the problem, contact the FTC and OCC Help Desk.
- b. The camera is working but provider cannot hear anything.
  - Instant Message the TelePresenter and ask him/her to assist.
  - Call the clinic room and use the phone for audio.
  - Ask the TelePresenter to contact his/her FTC for support.
  - CVT to home; ask the patient to call the OCC Help Desk for support.

### 4. Telephone Failure

- IM or email the provider side Medical Support Assistant (MSA) and patient side TelePresenter to inform them your telephone is not working and request electronic communication.
- If the internet is also out, please use your cell phone to inform the provider side MSA and ask them to communicate with the patient side staff.

### 5. VPN Failure

- Contact the National IT Help Desk to enter a ticket. State specifically the problem is causing a work stoppage and impacting clinical care. Follow up with your local IT providing your ticket number and problem.
- Inform the facility administrative staff.
- Attempt to connect using CITRIX to access CPRS and other clinical programs. If you can do this and it is clinically appropriate, please continue care via telephone and backup programs.
- Relocate to a local CBOC or medical center if the connectivity outage expects to be longer than half a day. Ask IT or the MH lead for an empty office or exam room. Any active ethernet port will provide connectivity. If there are any barriers, please call your supervisor to help coordinate with facility leadership.

### 6. VA Video Connect Failure

Try connecting by both Virtual Care Manager (VCM) and Video on Demand.





- Meet with the Veteran via telephone.
- After the session, contact the OCC Help Desk to enter a help ticket.

### 7. Loss of Internet Access

Inform the facility administrative staff and enter an IT ticket.

- · For in-clinic staff:
  - Call the patient or patient side clinic to inform them of the outage.
  - Meet with the Veteran via telephone. If the needed information is not available to conduct a full session, assess for safety and reschedule.
- For virtual/teleworking staff:
  - Relocate to a local CBOC or medical center if the connectivity outage expects to be longer than half a day. Ask IT or the MH lead for an empty office or exam room. Any active ethernet port will provide connectivity.
  - o Call the patient or patient side clinic to inform them of the outage.
  - Meet with the Veteran via telephone. If the needed information is not available to conduct a full session, assess for safety and reschedule.

### 8. Computer Failure

- Contact the National IT Help Desk to enter a ticket. State specifically the problem is causing a work stoppage and impacting clinical care. Also, call local IT with ticket numbers and situations.
- Inform administrative staff.
- Local providers, those who can come into Des Moines or Central Iowa CBOCs will go into the facility and use another computer to see patients.
- Virtual/Distance Providers: call facility MSA to coordinate both clinical care and follow up care.
- If you have a personal computer, when you call the National IT Help Desk for a computer failure issue, you can also request a pin that will allow you to access CITRIX for CPRS from a home laptop. Alternatively, using a PIV reader, you can access CITRIX or CPRS.

### TRAINING REQUIREMENTS





**Standard Training Requirements:** Health care professionals and staff participating in telehealth services (e.g., Telepresenter, Imager, Telehealth Clinical Technician) will adhere to VHA Telehealth Offices' role-based training requirements, which are in the <u>Telehealth Training Plans Community</u>. Required training must be completed before providing care via telehealth. Not all training is required. Additional service-specific training requirements may be included in the appendices.

**NOTE:** VHA Telehealth Services and other national clinical program offices develop telehealth training modules. Additional training requirements for a specific specialty may be developed and distributed locally. Facility staff and supervisors can contact the Facility Telehealth Coordinator or delegate for guidance on required training.

### **ACCESS TO MEDICAL RECORDS**

Electronic Health Record (EHR) Access — Telehealth health care professionals and other VA staff, who require patient site medical record access for the successful operations and oversight of the telehealth program (e.g., schedulers, quality managers), will obtain access to patient site medical records through Cerner or Web VistA Remote Access Management (WebVRAM)/CPRS. The telehealth health care professional site will request access to the patient site EHR as needed for providing care, prescribing controlled substances, and oversight through Appendix B. Rules of Behavior, Cyber Security, and Privacy training will be completed, verified, and renewed by the respective staff supervisor to stay current by the distant site before access is granted to health care professionals. The patient site WebVRAM Business Unit Administrator will review each request. If the telehealth health care professional site and/or patient-site facility does not have a WebVRAM Business unit, the request can be made through the Office of Connected Care Helpdesk. See the WebVRAM Intranet Site for instructions on how to set up a Business Unit if needed.

## RADIO NETWORK SHARING AGREEMENT BETWEEN POLK COUNTY SHERIFF AND JASPER COUNTY SHERIFF

THIS AGREEMENT for Radio Network Sharing ("Agreement") is made and entered into by and between the Polk County, Iowa, acting by and through the Polk County Sheriff's Office ("Polk County Sheriff"), and the Jasper County, Iowa, acting by and through the Jasper County Sheriff's Office ("Jasper County Sheriff"). The Polk County Sheriff and the Jasper County Sheriff may hereinafter be referred to individually as "Party" or collectively as the "Parties."

WHEREAS, the Polk County Sheriff's Office and the Jasper County Sheriff's Office are customers of RACOM Inc., and are a part of the RACOM Shared Area Radio Agreement (SARA) Network; and

WHEREAS, the Polk County Sheriff's Office and the Jasper County Sheriff's Office both will hold authorizations and/or licenses for radio tower sites located near or in the cities of Mitchellville and Runnells; and

WHEREAS, the Parties will share the use of their radio site equipment at their respective tower site for public safety communication purposes; and

WHEREAS, the purpose of this Agreement is to provide for the sharing of radio tower sites that are authorized and/or licensed to each Party; and

WHEREAS, this Agreement will expand the radio network coverage available to each Party and enhance public safety communications for the Parties and the public safety agencies for which the Parties provide PSAP and communication center services.

NOW, THEREFORE, in consideration of the purposes set forth above and the mutual obligations set forth herein, the Polk County Sheriff and Jasper County Sheriff do hereby agree as follows:

### Term:

This Agreement shall commence upon the signature of the parties. This Agreement shall remain in place indefinitely or until terminated by any Party pursuant to the terms of this Agreement.

### **Obligations:**

- 1. Polk County shall:
  - a. Have an active system maintenance agreement with RACOM Corporation for the shared Polk County tower site in Mitchellville.
  - b. Share the use of their radio site equipment for public safety communication purposes at the Mitchellville tower site.
- 2. Jasper County shall:
  - a. Have an active system maintenance agreement with RACOM Corporation for the shared Jasper County tower site near Runnells.
  - b. Share the use of their radio site equipment for public safety communication purposes at the tower site near Runnells.

### Termination:

Either Party may terminate this Agreement by sending written notice of the intent to terminate at least one hundred eighty (180) days prior to the intended date of termination.

### Consideration:

Any and all costs will be borne by the individual Parties whom incur the expense and cost associated with this Agreement, and not shared.

### Miscellaneous - General Provisions:

### 1. Entire Agreement

This Agreement constitutes the entire agreement between the Parties relating to the subject matter hereof and shall supersede (stands in place of) all prior or contemporaneous agreement(s), whether written or oral. It is understood and agreed that this Agreement incorporates and includes any and all prior negotiations, correspondence, conversations, agreements, or understandings applicable to the matters contained herein and the Parties agree that there are no commitments, agreements, or understandings concerning the subject matter of this Agreement that are not contained in this document. Accordingly, it is agreed that no deviation from the terms hereof shall be predicated upon any prior representation or agreements whether oral or written.

### 2. Headings

The section headings and subheadings contained in this Agreement are included for reference and convenience only and shall not enter into the interpretation of the Agreement, limit or otherwise affect the terms of this Agreement.

### 3. Amendments

The terms and provisions of this Agreement may only be amended by the express written mutual consent of the Parties.

### 4. Counterparts / Execution

This Agreement or written Amendments may be executed in counterparts, each of which shall be deemed an original, but all of which, when taken together, shall constitute but one and the same Agreement/instrument. Any counterpart delivered by commercially available electronic e-signature software or other electronic means shall have the same import and effect as original or manually signed (i.e., "wet-ink") counterparts and shall be valid, enforceable and binding for the purposes of this Agreement/Amendment.

### 5. Non-Assignment

Neither Party shall not assign its obligations or duties under the terms of this Agreement without the prior express written consent of the other Party.

### 6. No Employment/Agency/Entity

No separate legal or administrative entity is created by this Agreement.

## 7. Severability

In the event any portion or provisions of this Agreement or the application of any such provision to any Party or circumstances is determined by a court of competent jurisdiction to be invalid, illegal or unenforceable, this determination shall in no way affect the validity or enforcement of the remaining portions or provisions of this Agreement. The remaining portions or provisions shall remain in full force and effect.

#### 8. Waiver

Any waiver of any term or condition, of this Agreement, by any Party hereto of its rights with respect to any matter arising in connection with this Agreement shall not be construed as a general waiver or a waiver of any other term or condition.

## 9. Force Majeure

In the event of Acts of God, war, natural calamities, strikes, lockouts, or other labor stoppages or disturbances, civil disruptions, riots, epidemics, pandemics, acts of government or any competent authority having jurisdiction, or other legitimate cause beyond the reasonable control of a Party, and which such Party could not have prevented through the exercise of reasonable due diligence, but expressly excluding a Party's lack of sufficient funds to perform.

#### 11. Choice of / Governing Law

This Agreement shall be a binding agreement and any controversy, dispute or claim between the Parties arising out of or relating to this Agreement shall be governed by and construed in accordance with the laws of the State of Iowa.

## 12. Choice of / Governing Venue

Any and all litigation commenced in connection with this Agreement shall only be brought and maintained solely in The Iowa District Court For Polk County or in the United States District Court For The Southern District of Iowa. This provision shall not be construed as waiving any immunities available to Polk County.

#### 1. GENERAL INFORMATION AND SCOPE

Jasper County (County) through its Engineering Department (Engineer) will be accepting bids on or before 2:00 PM Wednesday January 31<sup>st</sup>, 2024, for the purchase of one (1) new or used semi-truck meeting or exceeding the equipment specifications.

Bids received will be opened at that time and read aloud by the Engineer at the Jasper County Highway Department. Only written sealed bids will be accepted. Bidders are allowed to attend.

The Jasper County Board of Supervisors (Board) in consultation with the Jasper County Engineer reserves the right to reject any and all bids, and to accept the bid which, in the opinion of the Board, represents the best interests of the County. Any exceptions to the bid documents must be clearly written and submitted on a separate page from the bid form.

Definitions: The following definitions are used throughout the bid documents:

Bidder/Vendor means a company or individual submitting a bid

Contractor means bidder awarded the contract

<u>Bid Documents</u> – means the cover sheet, index, bid process and procedure information, and attachments

County means the County of Jasper lowa

Board means the Board of Supervisors duly elected to serve the county

State means the State of Iowa

#### 2. QUESTIONS

Apparent areas of clarification, errors, conflicts, discrepancy, omissions, or other deficiencies present in the bid document shall be brought to the attention of the County Engineer no later than five (5) working days prior to bid opening. Communications shall be submitted in writing via the email address provided on the cover sheet. Verbal communications will not be considered. County Engineer shall respond via written Addendum emailed to the bidders. Bidders shall acknowledge receipt of addendums on the bid form.

#### 3. METHOD OF BID

Bidder must submit pricing and information as requested by the Bid Form. See Appendix B for Bid Form. Prices must be quoted in U.S. Dollars. Bidder must use the included Bid Form. Failure to fully complete the Bid Form will result in a rejected bid.

#### 4. BID SUBMISSION

Bidders shall mail or hand deliver a written sealed bid to the Jasper County Highway Department. The sealed bid shall include the completed bid form with addenda included as separate pages.

Bids shall be submitted on or prior to the date and time set forth on the cover letter. Failure to comply with this deadline will result in a rejected bid.

#### 5. BID RESPONSE REQUIREMENTS

For your bid to be considered, the following information must be provided on or before the due date and time listed on the cover page:

- Addendum Cover (Signature) Page(s), if applicable to this bid request
- Signature and Authority Affidavit Form, Appendix A
- Bid Form, Appendix B
- Complete specifications and descriptive brochure or detail for the product(s) bid
- Manufacturer's/Bidder's warranty information

The Signature and Authority Affidavit submitted with the bid proposal must be signed by the person in the Contractor's organization who is responsible for the decision as to the prices being offered in the Bid or by a person who has been authorized in writing to act as agent for the person responsible for the decision on prices and services. Failure to provide this forms/information with your bid submittal may disqualify your bid.

#### 6. METHOD OF AWARD

Award(s) shall be made based on the lowest total cost from a responsive, responsible bidder who meets specifications. Further, equipment lead times will be considered when making this award. The award will be made by board action at the regularly scheduled meeting on February 13<sup>th</sup>, 2024. Successful bidder shall be notified of award in writing via email after approval by the Board.

#### 7. BIDDER/CONTRACTOR QUALIFICATIONS

To be eligible for a contract award, you must meet the following:

- Licensed dealer in the State of Iowa
- Minimum of five (5) years of experience in the commercial heavy-duty truck market

#### 8. SPECIFICATIONS

Adequate detailed specifications of the product(s) offered must be included with your bid to establish equivalency and to ensure that the product being bid meets all specifications. Failure to provide product specifications and information may disqualify your bid. The County shall be the sole judge of equivalency and acceptability. Any attachments, documents, price lists, etc. to support your bid, must include the bid

number. Bid specifications may not be revised without an official written addendum issued by the County Engineer. See Appendix C for equipment specifications.

#### 9. DELIVERY

Delivery shall occur on or before May 1<sup>st</sup>, 2024. Please indicate on the Bid Forms your estimated delivery date. Bids with a delivery date after May 1st, 2024, will be considered last.

#### 10. F.O.B. DESTINATION FREIGHT INCLUDED

Bid prices shall include all transportation, insurance charges and installation/operation manuals. The owner shall take delivery of the semi-truck at the Jasper County Highway Department shop. The address can be found on the cover sheet of these bid documents. Bidders shall also provide a minimum of two (2) hours onsite operator training.

#### 11. SUBCONTRACTING OR THIRD-PARTY PAYMENTS

Subcontracting shall be pre-approved upon award by the County before any work begins. Subcontractors must abide by all terms and conditions of the contract. The prime supplier shall be responsible for all subcontractor(s) work and payment. The County will not pay any subcontractor or third parties directly.

#### 12. INVOICING REQUIREMENTS

The County's terms are to pay or reject invoices within 45 days of receipt. Before payment is made, it also must verify that all invoiced charges are correct as per this contract. Only properly submitted invoices shall be officially received for payment. Thus, your prompt payment requires that your invoices be clear and complete in conformity with the instructions below.

#### 14. APPEALS PROCESS

Notices of intent to protest and protests must be made in writing. Protestors should make their protests as specific as possible and should identify lowa Code or County Ordinances or Policies that are alleged to have been violated.

The written notice of intent to protest the intent to award a contract must be filed with County Engineer and received in their office no later than five (5) working days after the notice of intent to award is issued.

The written protest must be received no later than ten (10) working days after the notice of intent to award is issued.
