**APPROVAL OF DIGITAL TRANSACTIONS- ACTION 25-82.** Motion by Stone second by Herbold to approve the bank statement showing the monthly digital and online transactions and ACH transfers. Motion carried unanimously.

## **DISCUSSION ITEMS:**

A written naturalist report was distributed.

**NATURE CENTER SEPTIC BIDS- ACTION 25-83.** Four contractors were contacted to get bids for the nature center septic system. The project is unique because of the short turnaround installation time required. Both Herbold Construction and Robbie Howe responded they did not have time to do the project within the timeline. EWI bid \$27,497.77 and Fenner Underground bid \$20,698. When bids were compared, it was found that Fenner left out the pump and electricity to the pump in his bid. Van Zante noticed this on May 1, 2025 and emailed Fenner and asked for an updated bid, but didn't receive a response. Motion by Herbold, second by Stone to reject all bids due to one being a cost well above funding in hand and the other being an incomplete bid. Motion carried unanimously.

**LILLIAN JOHNSTON FUNDS- ACTION 25-84.** Van Zante reported that there is \$250,856.62 in the Lillian Johnston Fund at this time. Motion by Stone, second by Kramer to utilize \$75,000 of the Lillian Johnston funding for the nature center project and add Lillian Johnston Memorial to the donor wall. Motion carried unanimously.

**PUMP WETLAND PROJECT AT UHLENHOPP- ACTION 25-85.** Van Zante and Oldsen have been working with IDALS on a potential pump wetland project along Sugar Creek at Uhlenhopp Arboretum. A draft agreement for the project was reviewed by the county attorney that would pay for the project with IDALS funding of \$280,000. Motion by Herbold, second by Kramer to accept the contract from IDALS for the pump wetland project at Uhlenhopp. Motion carried unanimously.

**JASPER COMMUNITY FOUNDATION GRANT APPLICATION- ACTION 25-86.** A \$10,000 JCF grant has been written to fund classroom items for the nature center. Motion by Herbold, second by Stone to approve submitting the grant

application to Jasper Community Foundation for nature center classroom items. Motion carried unanimously.

**Other.** Nothing identified.

**ADJOURNMENT- ACTION 25-87.** With no further business appearing, motion by Stone second by Kramer that the meeting adjourn. Motion carried unanimously.
