DISCUSSION ITEMS:

A written naturalist report was distributed, and a report was given by Ratliff.

OPEN PUBLIC HEARING ON THE CONSTRUCTION OF PHASE 2 OF THE NATURE CENTER- ACTION 25-89. Motion by Herbold, second by Stone to open the public hearing regarding the construction of Phase 2 (Geisler Penquite Land Stewardship Lab) of the Nature Center. Motion carried unanimously.

CLOSE PUBLIC HEARING ON THE CONSTRUCITON OF PHASE 2 OF THE NATURE CENTER- ACTION 25-90. No public comments were received by any board members or at the public hearing. Motion by Herbold, second by Stone to close the public hearing regarding the construction of Phase 2 (Geisler Penquite Land Stewardship Lab) of the Nature Center. Motion carried unanimously.

APPROVAL OF PLANS AND SPECIFICATION OF PHASE 2 OF THE NATURE CENTER- ACTION 25-91. Van Zante presented plans and specifications that will be posted on the county website for bidding for the Phase 2 nature center project. Bids will be due July 10 and will be opened at a public Conservation Board meeting on July 15 at 8:30am. Motion by Herbold, second by Stone to approve the plans and specifications for phase 2 of the nature center. Motion carried unanimously.

MARIPOSA SEPTIC BID- ACTION 25-92. Sealed bids were requested for the septic systems at the Mariposa shop and for the 2nd cabin, all as one project. Bids received from Harthoorn Underground \$13,000, Jason Dop \$13,650 plus permit, Trunnel Excavating \$15,850, Rogers Septic \$15,972, and EWI \$20,874. Motion by Herbold, second by Stone to accept the low bid form Harthoorn Underground for the septic at the Mariposa shop and for the Mariposa 2nd cabin for \$13,000. Motion carried unanimously.

SKIDLOADER PURCHASE- ACTION 25-93. A skid loader purchase was approved by the Board of Supervisors in the amount of \$140,061.12 for a 2025 Caterpillar 275 XE from Ziegler. Motion by Herbold, second by Stone to approve the purchase of the Caterpillar 275 XE from Ziegler for \$140,061.12. Motion carried unanimously.

Foreman Property. The Vermeer family has inquired about purchasing the Foreman Property, which their property surrounds. Board members will take a trip to the property to take a look before any decisions are made.

Other. Peters and Van Gelder asked for an explanation about the schedule for the construction of the Red Rock Prairie Trail Phase 2. Van Zante will email them the current schedule with DOT and the engineer.

Board Member Concerns. Nothing identified.
