**APPROVAL OF DIGITAL TRANSACTIONS- ACTION 26-15.** Motion by Herbold, second by Stone to approve the July 2025 digital transactions.

**DISCUSSION ITEMS:**

A naturalist report was given by Cantu.

**Iowa County Conservation System (ICCS) Presentation.** Adam Shirley, Executive Director of ICCS, gave a presentation regarding the 70-year history of county conservation in Iowa, Chapter 350 of the Iowa Code, and the roles of conservation board members and county supervisors.

**EDUCATION CENTER SECURITY BIDS- ACTION 26-16.** Van Zante presented bids from both MCG and SCI for security at the nature center. MCG only bid cameras at \$5,832.00 and SCI bid both cameras and door locks/fobs at \$17,946.58. The Board of Supervisors voted in their meeting earlier that day that they will **require** conservation to use the SCI system since that is the one that is used in all other county buildings and is necessary to meet insurance purposes, and the cost of its installation is the responsibility of the conservation board. Motion by Herbold, second by Stone to accept the bid for \$17,946.58 from SCI for the security system at the Nature Center. Motion carried unanimously.
