CITY-SCHOOL ELECTION**

WHEREAS, the CITY-SCHOOL ELECTION was held as prescribed by law on November 4, 2025, and

WHEREAS, the Board of Supervisors and *ex-officio* Board of Canvassers has canvassed the vote of said elections in accordance with §50.24 of the *Code of Iowa*, now therefore

BE IT HEREBY RESOLVED that we, the undersigned members of the Board of Supervisors and *ex-officio* Board of Canvassers of Jasper County, Iowa, do hereby certify the following TURNOUT REPORT and RESULTS in the CITY-SCHOOL ELECTION, held November 4, 2025, and that no obvious clerical errors were identified during the canvass.

Three thousand sixty-two (**3,062**) people voted at the polls on election day.

Three hundred fourteen (**314**) absentee ballots were accepted for counting.

Zero (**0**) provisional ballots were accepted for counting (subset of absentee ballots).

A total of three thousand three hundred seventy-six (**3,376**) people voted.

All races are for a term of four (4) years unless otherwise noted.
