CURTIS "CURT" JACKSON TRUST RECEIPT OF FUNDS APPROVAL – ACTION 26-58. Trustee Jane Meyer of the Curt Jackson Trust is requiring receipt of funds to be signed by the board acknowledging the funds were received by Jasper County Conservation. The trust receipt of funds agreement has been reviewed and approved by county attorney Scott Nicholson. Motion by Stone, second by Nearmyer to approve the Curt Jackson Trust receipt of funds agreement. Motion carried unanimously.

OPEN PUBLIC HEARING ON THE PROPOSED PLANS, SPECIFICATIONS, AND FORM OF CONTRACT FOR THE CONSTRUCTION OF THE GEISLER- PENQUITE LAND STEWARDSHIP LAB PROJECT- ACTION 26-59. Motion by Stone and second by Kramer to open the public hearing on the proposed plans, specifications, and form of contract for the construction of the Geisler-Penquite Land Stewardship Lab Project. Motion carried unanimously.

CLOSE PUBLIC HEARING ON THE PROPOSED PLANS, SPECIFICATIONS, AND FORM OF CONTRACT FOR THE CONSTRUCTION OF THE GEISLER-PENQUITE LAND STEWARDSHIP LAB PROJECT- ACTION 26-60. Motion by Stone and second by Nearmyer to close the public hearing on the proposed plans, specifications, and form of contract for the construction of the Geisler-Penquite Land Stewardship Lab Project. Motion carried unanimously.

APPROVAL OF PROPOSED PLANS, SPECIFICATIONS, AND FORM OF CONTRACT FOR THE CONSTRUCTION OF THE GEISLER-PENQUITE LAND STEWARDSHIP LAB PROJECT- ACTION 26-61. Jamie Malloy of Studio Melee presented the plans, specifications, and form of contract for the Geisler-Penquite Land Stewardship Lab Project. The contract documents, including plans, specifications, and form of contract will be available at qualified plan rooms and at the Iowa Reprographics Online Plan Distribution website (iowarepro.com/plan-distributions). Physical copies are also available at Iowa Reprographics. A pre-bid meeting will be held at the nature center on December 11 @ 2:00 pm with any interested bidders. Bids will be due January 8, 2026 at 10:00 am to the Jasper County Conservation Office. The project completion date has been set for October 30, 2026. Motion by Stone, second by Nearmyer to approve the plans, specifications, and form of contract for the Geisler-Penquite Land Stewardship Lab Project. Motion carried unanimously.

APPROVAL OF SHIFT DIFFERENTIAL PER JASPER COUNTY EMPLOYEE HANDBOOK- ACTION 26-62. Board members reviewed the shift differential

policy in the Jasper County Employee Handbook. It reads: Effective July 1, 2025, in addition to the employee's regular hourly rate of pay, a shift differential of seventy-five cents (\$0.75) per hour for any regularly scheduled permanent shift of which four or more hours occur between 3:00 PM and 11:00 PM, and one dollar (\$1.00) per hour in which four or more hours occur between 11:00 PM and 8:00 AM. Employees that work rotating shifts on a regularly scheduled basis shall be eligible for shift differential. Applicable shift differential shall be paid for all hours worked. (Res. 25-25). Motion by Kramer, second by Stone to authorize the shift differential pay for any conservation staff that it may apply to either now or in the future. Motion carried unanimously.

Geocaching Event Request to Utilize Environmental Education Center. Van Zante met with in person with Mark Metz, of the Iowa Geocachers Organization, to clarify his request to partner with JCCB and to utilize the Environmental Education Center for a Hike-n-Seek Event. Metz wants to plan events in several of our parks and then utilize the nature center all day on Saturday September 19, 2026, as an event "homebase" and for a meal in the evening. Board members were very supportive of partnering with the event but feel that the plan to utilize the basement of the nature center would be risky for Metz's group with an unknown basement finish plan and schedule at this time. Board members suggested Metz have an alternate plan for his "homebase" needs on September 19, 2026.

Other. Van Zante reminded board members of the Baxter CVT meeting that will be held on December 16, 2025, at 6:00 pm at the Community Center located at 203 S Main in Baxter.
