Use of any Jasper County property requires approval from the Jasper County Auditor or one of their authorized staff. Please see the Auditor's Office for Application Request Form.

The Auditor, or one of their authorized staff, in the exercise of their own discretion may grant variances from these rules and requirements for cause shown on a case-by-case basis and reserves the right to refuse use of any Jasper County property for any event that may compromise the security of the grounds or the safety of either the employees or the general public.

Installation Practices

SCI will ensure that all cables will be dressed and terminated in accordance with the recommendation made in the TIA/EIA-568-B standard, manufacturer's recommendations and the best industry practices. The pair untwist at the termination point will not exceed .5inches. The bend radius for the cable in the termination area shall not exceed 4 times

the outside diameter of the cable. The cable jacket will be maintained as close as possible to the termination point of the cable.

Firestop System / Bonding and Grounding / Support systems

Purpose:

To support the recruitment and retention of Emergency Medical Service Providers within Jasper County by offering financial reimbursement for training costs to eligible individuals who commit to serving locally.

Eligibility Requirements:

1. **Completion of EMT Training:**

Participants must complete a certified EMT training program approved by the State of Iowa.

2. **State Certification:**

Participants must obtain their official EMT certification through the Iowa Department of Public Health.

3. **Service Commitment:**

Participants must actively practice as a certified EMT within Jasper County for a minimum of **one (1) year** following certification.

Reimbursement Terms:

- Reimbursement will only be issued **after** all eligibility requirements are met, including:
 - Proof of course completion.
 - Proof of Iowa state EMT certification.
 - Proof of active service within Jasper County.
- The reimbursement will cover approved expenses directly related to EMT training (e.g., tuition or books).
- Reimbursement may be capped depending on the number of students and available funds.

Failure to Meet Requirements:

- If a participant **does not obtain certification** or **fails to begin practicing in Jasper County**, they will **not** be eligible for reimbursement.
- If a participant **leaves their position or relocates outside of Jasper County** before completing the entire one-year service requirement, they or their department will be **required to repay the reimbursed funds in full**.
- Reimbursement form and proper documentation must be submitted within 30 days of certification

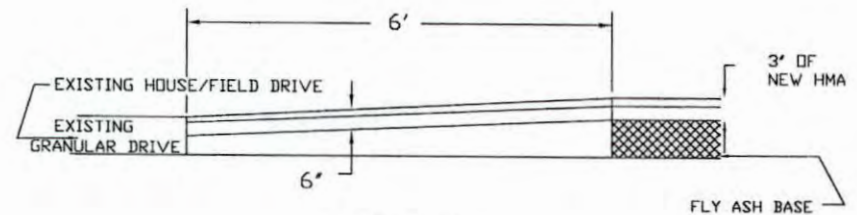
TYPICAL CROSS SECTION

WHEREAS, the Jasper County Secondary Roads department (COUNTY) through a 3rd Party bridge inspection firm completed the inspection of the bridge over the Indian Creek on N 95th Ave W known as Bridge E14 by the County and as 199630 by the Federal Highway Administration (FHWA), and

WHEREAS, the latest inspection revealed a cracking and spalling deck with exposed reinforcement bar, timber pile decay and concrete abutment and pier deterioration, truss corrosion, and

WHEREAS, to resolve the issues with the abutments and pier would require the removal of the deck, truss support structure, and abutments and pier then complete replacement of the abutments and pier, and

WHEREAS, the replacement of abutments and pier, truss, and deck could not be in-kind since it would need to meet current bridge loading requirements to avoid load posting immediately after completion, and

WHEREAS, a replacement not in-kind would be a construction project and in-turn subject to programming with the Iowa DOT and subsequent review and/or permitting with the United States Army Corp of Engineers (USACE) and the Iowa Department of Natural Resources (DNR), and

WHEREAS, this would result in a replacement bridge that is longer, wider, and at a higher elevation and in turn necessitating the need for additional permanent easement for public highway (right-of-way) and the allocation of approximately \$2,500,000 in funding, and

WHEREAS, the County Highway Bridge Program (HBP) funding is allocated to the replacement of bridges on paved Farm-to-Market (FM) routes, this route and bridge are not part of the FM system and therefore ineligible for funding, and insufficient funds are currently available in the Local Secondary Roads Budget (Local Funds), and

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Jasper County, Iowa, that the County hereby authorizes the removal of this bridge and the subsequent programming of a replacement for said bridge only when a source of funding is successfully awarded and/or budgeted and in turn approved by the Board of Supervisors of Jasper County, Iowa:
